## How to utilize the benefits of professional organizations & associations to help you grow your business?

A couple of years ago I wrote an article entitled: "How to use associations and organizations membership to secure clients for your business. I have listed several benefits that a business owner should utilize to help them to secure clients and possibly increase their business recognition and revenue. I believe those reasons are still relevant today and worth re-mentioning.

Some of the benefits of joining and participating in your professional associations or organizations are as follows:

- Most professional associations offer their members continuing education that would include workshops, seminars, webinars, conferences and teleconferences.

- Newsletters and magazines are another benefit of joining professional organizations. These publications will keep you informed of the latest news, case laws, trends and updates in your industry.
- Always read archived newsletters and articles to learn more about your practice areas such as: what have worked and didn't work for your industry in the past.
- Attending organizations meetings are important because they keep you

informed of the changes in your industry such as new products and services.

- Meetings participation allows you to have a voice in discussions about new ideas and gives you reviews on how your industry is doing in the market.
- However, to get the most benefit from joining an association is to get involved. Volunteering your services and time can come in many forms such as: contributing to their newsletters where you may be viewed as an expert in your industry. Participating on your committee boards will allow you to make decisions that will affect your business and gives you a voice for changes within your industry.
- Most importantly, organizations and associations establish professional standards, gives your business credibility, keeps you updated on legislative news & activities, recognition of your profession and update court rulings. It can also increase awareness & value in the market place.

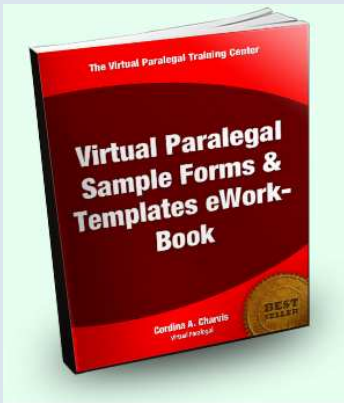
