

## Sacramento Region's Dangerous Place to Drive

The latest report published by the Office of Traffic Safety claims that in 2009 nearly 11,000 people were injured in **car accidents in Sacramento.** This high number indicates that Sacramento is very dangerous place to drive. On the other hand Lincoln as well as busy Highway 65 appear to be the safest streets in the region. What's more Lincoln is the 10th safest city in California out of 98 cities its size.

Unfortunately Sacramento had the highest alcohol-related injury and fatality rate among the state's 13 largest cities.

## California DUI Accident Lawyers

Driving under the influence is extremely dangerous and illegal. The California law prohibits from driving with blood alcohol content (BAC) of 0.08 percent or higher. The California Vehicle Code Section 23152 (a) says: "It is unlawful for any person who is under the influence of any alcoholic beverage or drug, or under the combined influence of any alcoholic beverage and drug,

When a DUI accident results in serious bodily injury or death, California law provides for felony charges against the offender. Despite these serious consequences, for some reason, it remains almost tacitly acceptable to drive after drinking in our society as long as you don't get caught. The price that is paid is too high. Since some people don't seem to be getting the message, California should do more to prevent DUI related deaths, including stiffer penalties

for all offenders, alcohol treatment programs, ignition locks, and programs like mandatory designated drivers.
