We represent the plaintiff in the above referenced matter. On June 7, 2011, the parties appeared by telephone. After discussion with the Court about the difficulties of physically producing comparator data, the plaintiff agreed to accept the comparator data in electronic form for ease of handling and related costs. Based upon the representations of the defendants' CITY and KEITH SPADARO, the court ordered the defendants' to produce the electronic data by July 8, 2011.
