Single Auto Ship = 100 PV* = Three products per month

*PV = Personal Volume

Double Auto Ship = 200 PV* = Six products per month

*PV = Personal Volume

You need to have two personally sponsored people to qualify for income.

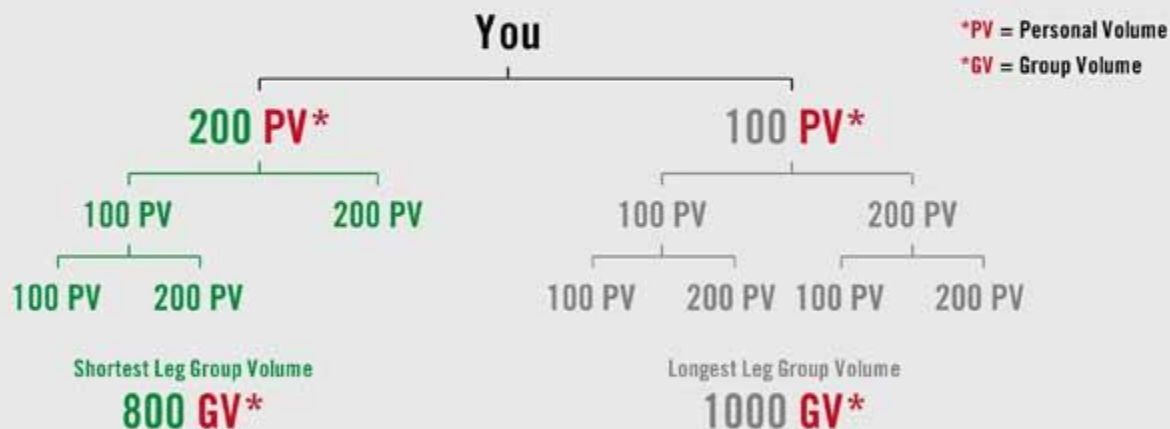
Fast Track Bonus: During the **first 30 days** of any distributor you personally sponsor, you have the opportunity to earn this bonus commission. For every distributor you personally sponsor you will receive 25% of their first month's total volume (PV). In addition, during the **first 30 days** of every new distributor who is the next level down from your Personally sponsored distributor you will receive 10% of this distributor's first month's total volume (PV). The **Fast Track Bonus** is designed as extra incentive and motivation for distributors to begin building their business as quickly as possible and ensuring **success!**

Bulk Orders: Bulk orders consist of 9 or more products. You will receive an additional 5% (if you are on single auto ship) or 10% (if you are on double auto ship) of **any** personally sponsored distributor's bulk order.

Team Commission: You will receive 10% of your shortest leg's GV as a residual income.

Executive Check Match: In addition to the bonuses and incomes already discussed, once you reach 10,000 GV per week for two consecutive weeks in your shortest leg, you will permanently receive 20% of the income amounts of those distributors you have personally sponsored who have at least 200 PV! This is based on the income of those you have personally sponsored.
