(57) **CLAIM**

The ornamental design for an ostomy bag cover, as shown and described.

DESCRIPTION

FIG. 1 depicts an isometric view of the ostomy bag cover.

FIG. 2 depicts a front elevation view of the ostomy bag cover.

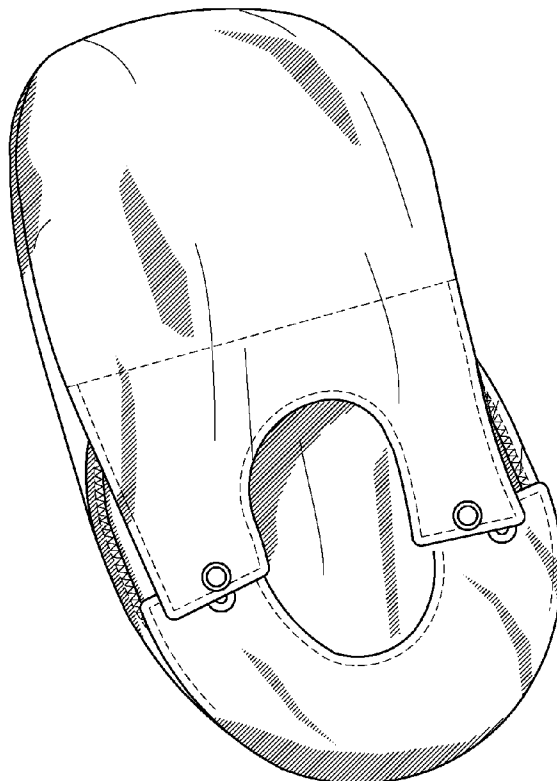
FIG. 3 depicts a rear elevation view of the ostomy bag cover.

FIG. 4 depicts an enlarged front elevation view of the ostomy bag cover with the flap folded over; and,

FIG. 5 depicts a side view of the ostomy bag cover, with the top section shown in an expanded configuration as it would look containing an ostomy bag.

The dashed lines in FIGS. 1, 2, 4 and 5 represent stitching, and form part of the claimed design.

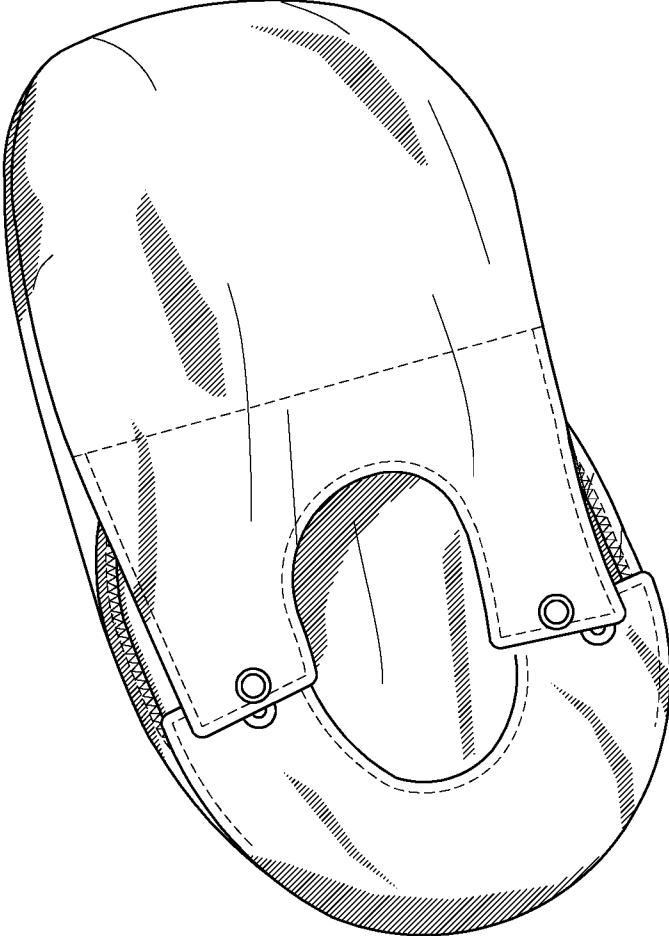

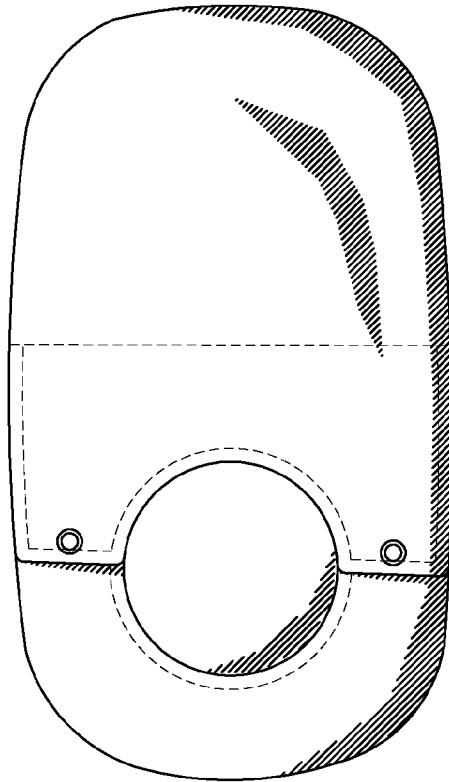

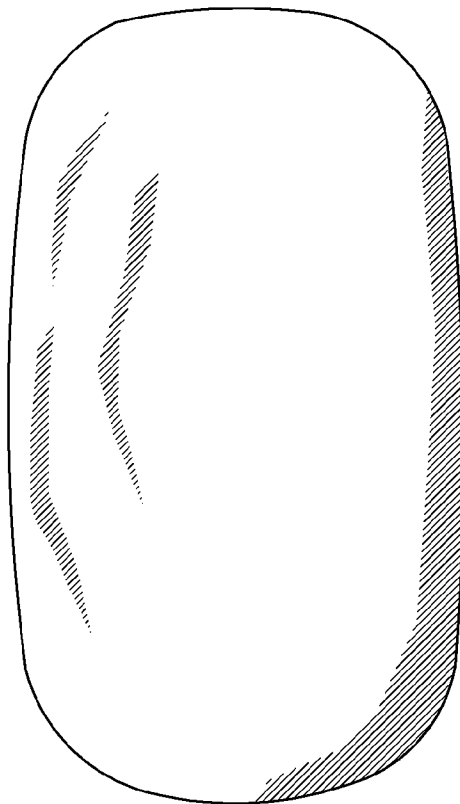

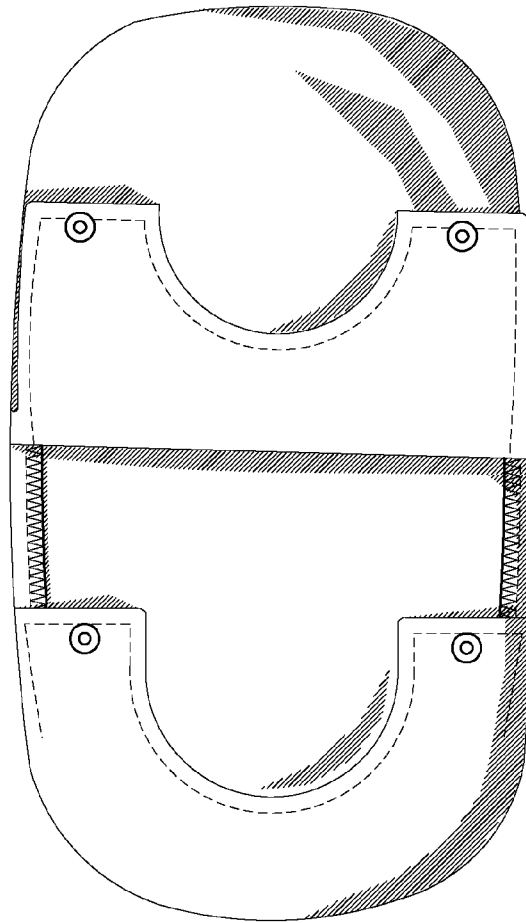

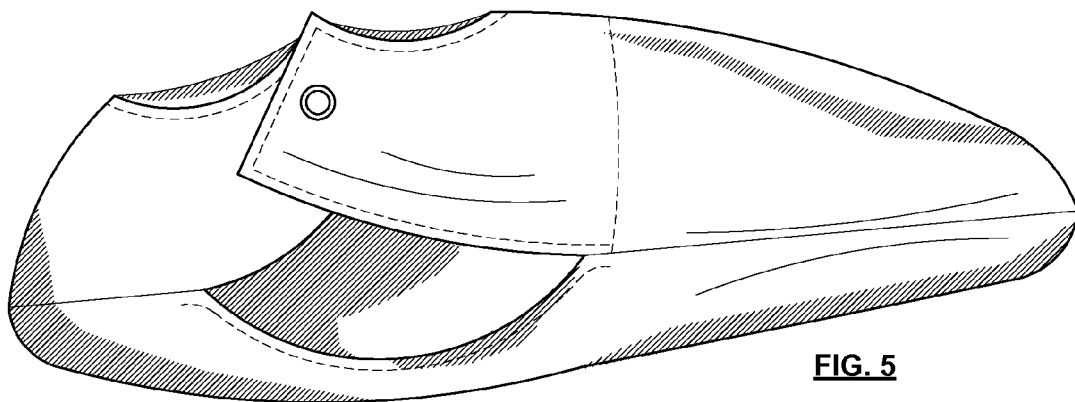
