The San Diego County Water Authority ("Water Authority") has extended its submission deadline and issued an Addendum to its Request for Proposals (RFP) from qualified firms or a consortium of firms to design, install, own, operate and maintain solar power systems at Water Authority facilities. As described in our original notification for

the Water Authority RFP, the solar power systems may contain inverters, conduits, and other equipment necessary to deliver solar electricity to the Water Authority at interconnection points, carports, shade structures and mounting systems. Goals and objectives of the Water Authority include utilizing agency-owned spaces, such as rooftops, for solar power systems; purchasing solar-generated power through power purchase agreements; and reducing the cost of developing solar energy systems by making a significant long term investment. The Water Authority desires to establish relationships with solar power system developers to facilitate highly cost-effective development of solar power systems at the Water Authority and investment in solar power systems by industries and businesses within the region. The Addendum to the RFP includes the April 8, 2009 Pre-Proposal Meeting Minutes, additional responses to requests for clarification regarding the RFP, and attachments providing information for each of the sites visited on April 8, 9

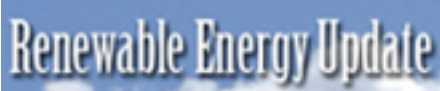
