How NATURA's Compensation Plan Bonuses Work

POSITION BONUS

Distributors who qualify to leadership positions will receive bonuses of \$150 to \$3,000 every month.

LEADERSHIP BONUS

Natura will pay every month position a Leadership Bonus from 2% to 4%. The Leadership Bonus pays all distributors that have in their organizations, in different legs, or 2 Leaders either in the same position or the one right below. This bonus can be shared up to 2 generations when you have in your organization a leader in the same position.

COMPANY'S TOTAL SALES BONUS

Natura will distribute every month up to 6.5% in bonuses from the company's total sales in points, for those distributors that reach leadership positions. Depending on the position, there will be a 0.5% and up to 2%. The percentages will be shared in proportion to the volume generated on the first 4 levels. The volume will be calculated without any compression. This bonus will be paid to distributors that reach at least Jade and that have a leader below or who is in the same position.

PERSONAL PURCHASE SURPLUS

Natura will pay distributors and leaders a 50% for personal purchase surplus. Your sponsor will receive 5%, the following up line sponsor will receive 5% up to 27% depending on the position reached that month. This surplus will continue paying in an ascending fashion as regular points are kept, from 8% up to 31%.

DYNAMIC COMPRESSION

Natura will pay dynamic compression monthly. This means that all levels go up, compacting, covering empty spaces left by inactive distributors.

GROUP VOLUME QUALIFICATION

In order to qualify for a leadership position, distributors must distribute their volume in at least 3 different legs. The volume taken in consideration is on the strongest leg, 60% of the required volume to reach the desired position. From the second strongest leg 30% is required to reach the desired position. The other 10% of the volume will be taken from remaining legs.
