Aromazona Candle Company sells long-lasting, soy candles. All of its candles are manufactured in the United States. The Company's candle products are meant to be healthier for your health than other common candles.

### Discussion of Opportunity

Aromazona Candle Company's website states the following regarding distributorships:

"Our Distributors oversee our Home ([www.mlmllegal.com](http://www.mlmllegal.com)) Party Division and our Consultants. Our Distributorships are limited by distance and require an investment in stock to begin and minimal purchase requirements. They build their business through home parties, fundraisers, shows, direct sales and the option for Consultants to work under them."

Consultants have the choice of becoming either a virtual distributor (selling exclusively online) or becoming a home distributor (selling products in person).

Virtual distributors receive the following benefits from becoming a representative:

**Have your own Virtual Distributorship**  
Choose from 2 plans:  
Monthly Plan - \$9.99 a month (due the 1st of each month)  
Yearly Plan - \$7.99 a month (\$95.88 due every January 1st)

If you choose the Monthly plan, your fee for that month will be prorated if you start after the 1<sup>st</sup> of the month. If you choose the Yearly Plan and start after January 1st, your fee will be prorated from when you start until December 31<sup>st</sup>. There are no refunds for either plan if you choose to quit before the end of your time.

- Earn 30% for all regular items and 20% for all discontinued items purchased through your web pages special link, including your own purchases.
- Commissions are calculated on the purchase price of any items by the customers, after any discounts.
- Receive a \$5 referral bonus for each new Virtual Distributorship that signs up through your web pages special link that chooses the Yearly Plan.
- Receive commissions by check every 2 weeks as long as your balance is \$25 or higher. Lower balances are rolled over to next period.
- No minimum sales requirements. All you have to do is advertise your new web page.
