FACTS:

Oct. 7, 1997, pltfs were all rear seat passengers in deft Gandhi's car on their way home from work at a Wheeling factory. Gandhi was driving southbound on River Rd. in Mt. Prospect when a northbound UPS truck driven by Mulcahy made a left turn at Kensington across their path, resulting in a collision. Ila F-43 sustained bilateral shoulder fractures with right shoulder dislocation and partial tears of both rotator cuffs (\$7,656 medl., \$2,000 LT). Rasila F-48 suffered a concussion, infraorbital nerve contusion, low back pain and small scar on left cheek (\$7,017 medl., \$900 LT). Parmar F-40 suffered a comminuted and displaced fracture of right humerus which healed with a slight angular deformity, plus a right rotator cuff tear (\$14,675 past medl., \$15,500 future medl. for rotator cuff surgery, \$3,144 LT as assembler). Defense for UPS contended M-25 Mulcahy entered intersection on a green light and began his turn after light turned red, so Gandhi ran the red light. Deft M-45 Gandhi claimed his light was green when he entered intersection, but had told investigating police officer at scene that light turned yellow as he entered intersection. Two independent witnesses supported Mulcahy's contention that light was red. Defense also contested extent of injuries. Pltf counsel Wiederer notes that Mulcahy testified about the UPS bonus plan which rewards speed in completion of functions, and that Dr. Kanter testified to earning around \$200,000 per year as an expert witness. Defts filed post-trial motions.
