**MOTION TO RECONSTITUTE OFFICIAL CREDITORS' COMMITTEE**

The Bankruptcy Administrator for the Western District of North Carolina moves the Court for an order to reconstitute the Official Creditors' Committee and says:

1. This is a Chapter 11 proceeding in which a voluntary petition was filed on or about June 5, 2010.
2. On June 17, 2010, an Order Appointing Official Creditors' Committee was entered in this case.
3. Upon information and belief, Garlock Sealing Technologies, LLC ("Garlock") paid, in full or a portion of, the claims of the creditors included on the List of Creditors Holding 20 Largest Unsecured Claims (the "List"). As a result, most of the creditors appointed to the Official Creditors' Committee (the "Committee") are ineligible to serve as they are no longer creditors of the Debtor.
4. Dexter Foundry Inc. is the only eligible creditor remaining on the appointed Official Creditors' Committee.
5. On September 13, 2010, the Bankruptcy Administrator's Office filed an Amended Notice to Creditors Holding Twenty Largest Unsecured Claims (the "Amended Notice"). The Bankruptcy Administrator's Office received two acceptances to the Amended Notice within the time period allowed to respond.

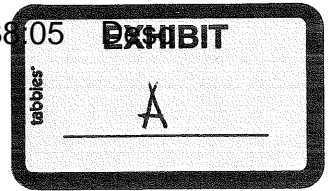
