MOTION TO APPOINT SPECIAL ADMINISTRATOR



ORDER

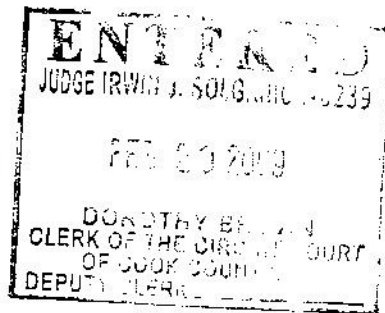
