On Saturday, September 9, 2006, at approximately 1:39 a.m. police units were dispatched to the jail on an assault that occurred at another location. Upon arrival at 1:40 a.m., we spoke to Brandon Scott Denton, the victim. I could see that he had numerous abrasions on his forehead, both arms, and it appeared that he had been strangled. He stated that his father, Roy Denton, and brother, Dustin Denton, had done this to him just minutes earlier. He explained that while he was at work at the Dayton Taco Bell, Dustin called him and asked if he had a ride home. Brandon stated that Dustin wanted to talk to a female friend and co-worker. Brandon stated that because Dustin sounded drunk he did not let him talk to her. Brandon stated that he got a ride home from someone else due to him believing that both his father and brother were intoxicated. Brandon stated that when he arrived home his brother starting arguing with him, which led to Dustin hitting him several times. He stated that the large abrasion on his forehead was caused by this. He stated that during the assault, their father, Roy, got involved in the fight. Brandon stated that Roy grabbed him around the neck and strangled him. His neck was very red and was consistent with his statement. He also had abrasions on both arms. He also stated that Dustin broke his eyeglasses during the assault. I took pictures of his injuries. We went to the Denton residence located at 120 6th Ave, which is inside the city limits of Dayton, TN. We arrived at 2:13 a.m. Roy came to the door and I asked him what had happened with his son. He would not answer me. I also found Brandon's eyeglasses on the front porch, broken. I advised Roy that he was under arrest for domestic assault. I also advised him that I needed to speak to his other son, Dustin. He stated that Dustin was not home and Roy began to turn away from us. I handcuffed his right arm at this point and he attempted to close and lock the door on his home. I told him that we had to find Dustin and that he needed to give me his other hand. I was able to handcuff his other hand together. We placed him in a patrol car and located Dustin in a bedroom of the home. I advised him that he was also under arrest for domestic assault. He was placed in custody and both Roy and Dustin were transported to the Rhea County Jail in separate cars. Roy was transported at 2:17 a.m. and arrived at the jail at 2:18 a.m. Dustin was transported at 2:27 a.m. and arrived at the jail at 2:28 a.m.
