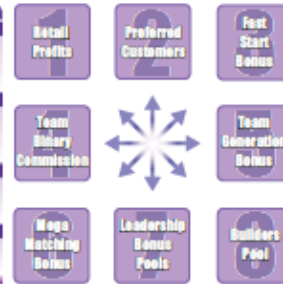

21 Day Upgrade: Regardless of the enrollment option you choose, you can upgrade to Titanium or Platinum within 21 days of your enrollment date. To complete the Upgrade, simply accumulate wholesale purchases within 21 days of your enrollment date that total the amount of wholesale value necessary to reach Titanium (\$200-\$899) or Platinum (\$900 or higher).

Orders placed for Upgrade must be completed by clicking on "Place Orders" in the "My Orders" section of your Back Office, and then selecting "Upgrade". Your three original Platinum Business Centers are upgraded but each reserve center must be activated with a new, separate order.

After the 21-Day Upgrade period has passed, you can still upgrade (to Platinum ONLY) with a onetime \$900 wholesale purchase or by accumulating wholesale purchases that total \$1800 in any one calendar month. The onetime purchase upgrades only the Business Center in which the order was placed, not any other Business Centers or Reserve Centers.

1. Retail Profit

As an AMEGA Business Associate (BA), you may purchase products at the wholesale price and resell them at the retail price. This wholesale to retail markup is up to 10%. You may also sell product on your BA Replicated Website and 10% of the retail profit will be included in your commission check which can be tracked online from your Back Office.

When customers purchase products from your BA Replicated Website, the corresponding Business Volume (BV) counts as your 1st Generation Group Business Volume (GBV) where you receive an additional 10% commission based on the Team Generation Bonus (see Item 5).

2. Preferred Customers

A customer who does not wish to become a BA, but still wants to consume Amega products on a monthly basis, may become a Preferred Customer. Preferred Customers purchase Amega products at the BA wholesale price in exchange for enrolling in a monthly automatic shipment program. They can cancel at any time. The volume from Preferred Customers counts as part of your 1st Generation GBV, and you receive a 10% commission!

3. Fast Start Bonus: 10%

You will earn a Fast Start Bonus every time you personally enroll a new BA who purchases a Silver, Titanium or Platinum Package, or makes an Upgrade purchase within 21 days. The Fast Start Bonus is 10% of the wholesale amount of the new enrollee's Initial or Upgrade purchase, not counting the Business Kit.

4. Team Binary Commissions

Team Binary Commissions are based on a two-legged Binary structure that pays an Active, Qualified BA a 10% commission of the Group Business Volume (GBV) on the side of the Binary with the lesser amount of GBV. This commission is paid on Enrollment Orders and Upgrades only and is calculated daily/paid weekly with a **monthly requirement to be Active (minimum 80 BV)** and also maintain one Active, personally sponsored BA on each side of the Binary. If a BA is Active but no commission is due, the strong side volume continues to hold and grow from month to month with no limitation. However, if a BA is inactive for a period of 6 months, volume will be flushed from strong side starting from the oldest month and will continue in this manner until the BA becomes Active again.

BV requirements only apply to one single BA and not each and every Business Center held by a BA.

There must be at least 200 GBV in the lesser leg or the payout will carry over to the next day. Any Business Center that has achieved the maximum payout for a particular day will have the matching unpaid BV on both legs flushed to avoid overpayment. The unmatched BV in the stronger leg will be carried forward to the next day.

5. Team Generation Bonus

Team Generation Bonuses are paid on line of sponsorship, based on the number of personally sponsored Business Associates active with a minimum of 80 BV. This bonus is paid on all purchases except Enrollment Packages and Upgrades, which are paid as part of the Team Binary Commission.

When each BA in your line of sponsorship purchases or retails product, you will receive a Team Generation Bonus on up to 7 Generations of Business Associates. This is based on their Bonus Volume (BV). To receive the Team Generation Bonus a BA must be active by maintaining a minimum of 80 Personal BV (PBV) monthly and also be qualified.

6. Mega Matching Bonus

Mega Matching Bonuses are based on a match of the Team Binary Commission and Team Generation Bonus of Business Associates in your line of sponsorship. Business Associates are always paid at the level of their current qualification, but they never lose the highest pin level designation. The multi-tier Mega Matching Bonus is paid on up to 7 generations. To qualify for this bonus, Business Associates must maintain a higher PBV depending on their level of qualification. (See chart below.)

** In order to qualify for the Leadership Bonus Pools (World Pool and Country Pool):

- For Blue Diamond, each of the 3 Left and 3 Right Diamonds must be Active and Qualified.
- For Black Diamond, each of the 3 Left Blue Diamonds and 3 Right Blue Diamonds must have earned that month's Country Pool and thereon for succeeding pin levels.

*** Reward Vouchers, Travel Vouchers, Car Vouchers and Ideal Home Vouchers are only paid during the first month that you qualify for the specific incentive. They are one-time bonuses.

8. Builders Pool

The Builders Pool is designed specifically for Business Associates who are new to the business and are aggressively working towards the higher levels of the compensation plan. Omega rewards these valuable future leaders with this potentially lucrative pool.

For every 1000 BV Increase in the lesser leg, over and above the volume of the lesser leg from the month prior, the BA will receive one share of the Builders Pool. The Builders Pool is an amount equivalent to 1% of the total Country Pool Commission paid by the company and split to a shared value. This pool is open to Active, Qualified Business Associates and Diamonds. Blue Diamonds and above do not qualify for this pool.
