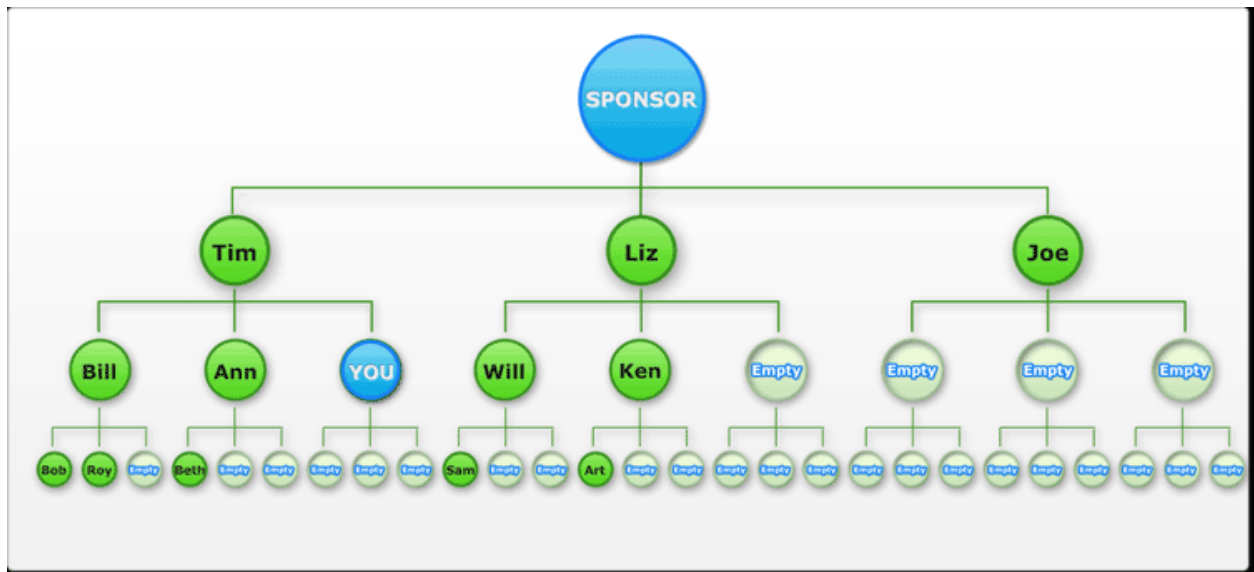

Stage 2 - Standard Representative

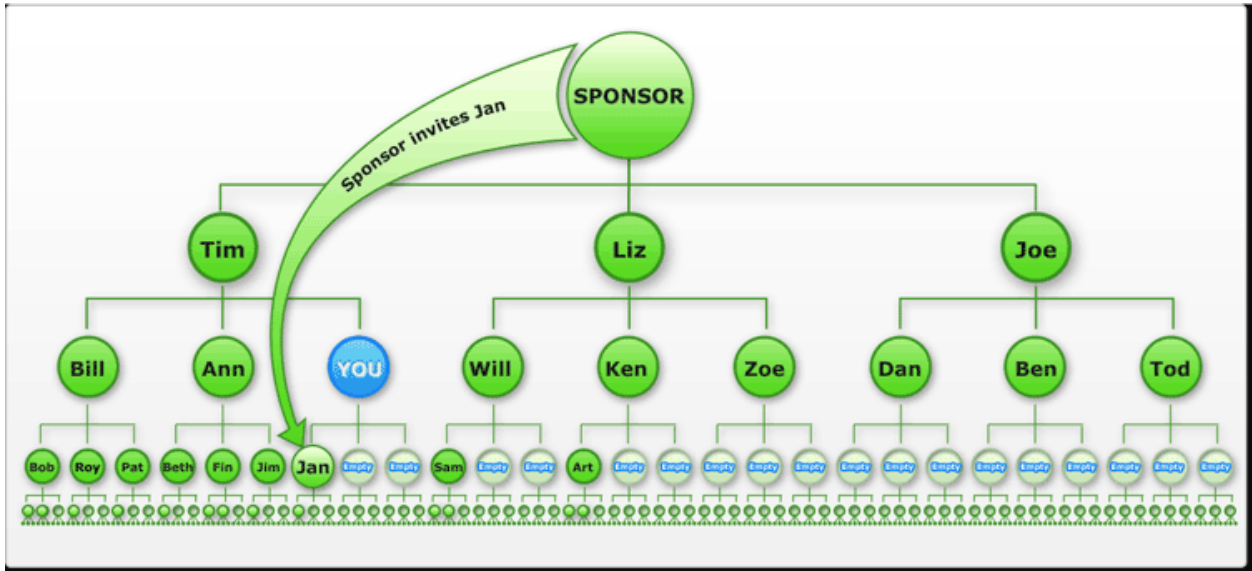


- In the image below, the first empty position is on the second level of your sponsor's matrix - on Tim's first level



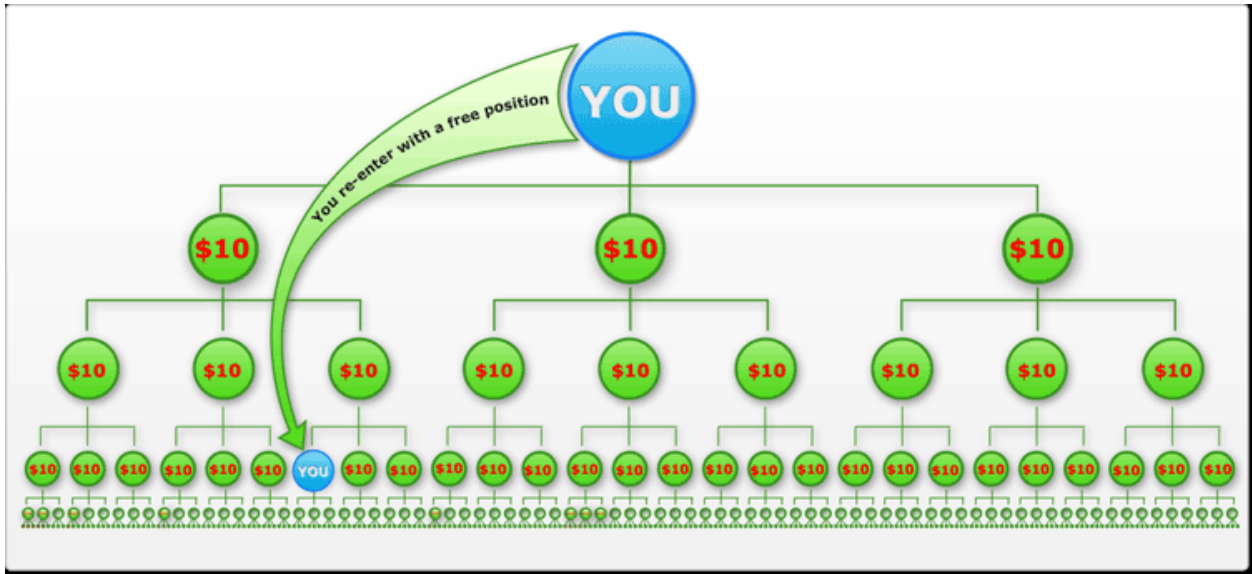
**Upline Spillover:** One of the major benefits of the matrix is the team building.

- The 2 people above your sponsor are also paid \$10



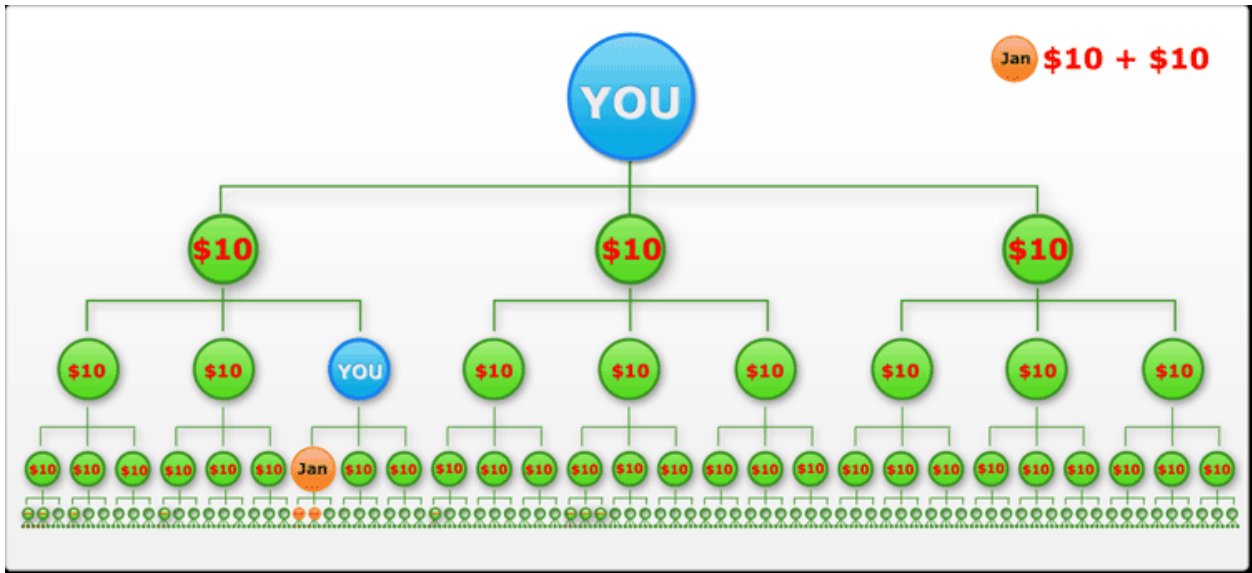

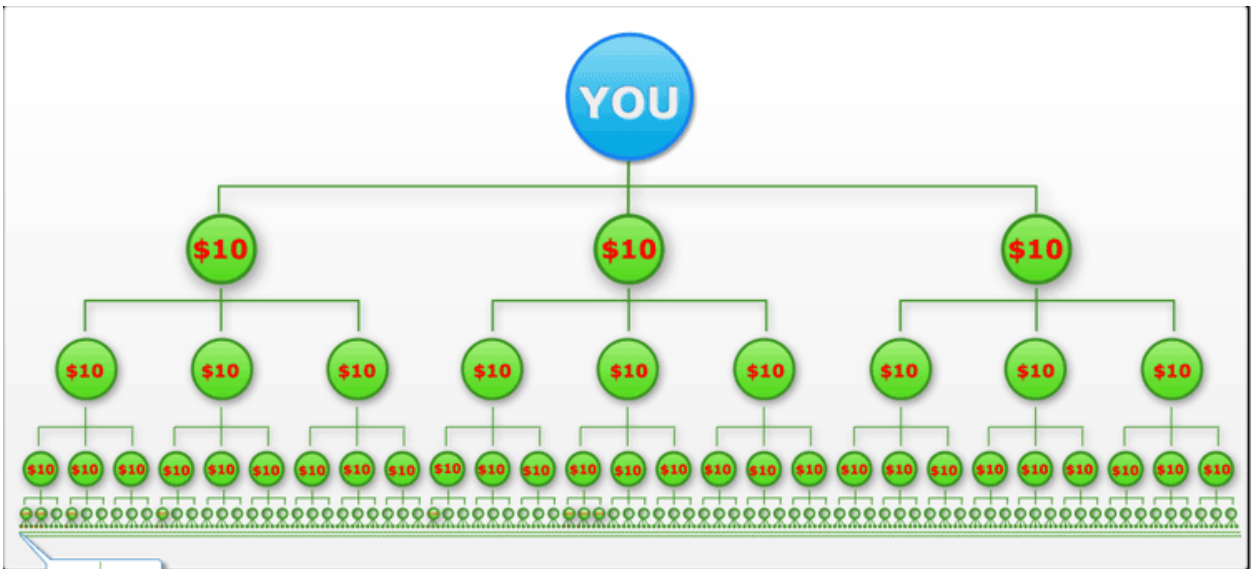
