# 3. Victim's state of mind not relevant in harassment or bias. <u>State v Ravi</u> \_ NJ Super. \_\_.

Defendant was convicted of multiple counts of invasion of privacy, bias intimidation, hindering prosecution, and tampering with evidence. The jury found defendant guilty on four counts directly predicated on N.J.S.A. 2C:16-1(a)(3), a now constitutionally defunct law pursuant to the Supreme Court's holding in <u>State v. Pomianek</u>, 221 N.J. 66, 69 (2015). The State conceded that the convictions under these four counts are void as a matter of law. A-4667-11T1
