Dutch Court Rules Active Webcam Policies Violate Human Rights

A Dutch court ruled in favor of a Dutch national employed by a U.S. company who was fired for refusing to turn on his webcam. The ruling was part of the employee's wrongful termination lawsuit against his former employer, Chetu, Inc, a Florida-based software company. Chetu's company policy requires employees to have their webcams and screens visible on remote viewing software for several hours daily. The employee was fired for "refusal to work" and "insubordination" when he refused to comply and open his webcam cover. <u>Read more</u>
