Applicant is the mother of the Proposed Ward and her address is _____, Travis County, Texas. Applicant desires to be appointed Guardian of the Person and Estate of Proposed Ward, which Estate is valued at \$_____, including any compensation, pension, insurance, or allowance to which the Proposed Ward may be entitled. The Estate of the Proposed Ward generally consists of the following types of property: bank accounts and certificates of deposit; and personal effects. Applicant's interest in the appointment of a guardian is as a relative of the Proposed Ward, as previously indicated, she is eligible by law to act as Guardian.

This Court has venue over these proceedings because one or both of _____'s parents reside in this county, and _____ is a minor.

VI.

Proposed Ward is a minor and the nature and degree of his incapacity are as follows: The incapacity is minority, in that the proposed Ward is 12 years of age.

Applicant states to the Court that the following facts and reasons support the request for appointment of a Guardian and the granting of the requested powers: The child has received a large inheritance which is held at this time by a financial institution and cannot be disbursed to any person not appointed as the guardian of the child. The financial institution will only hold the money for a period of five years at the end of which the money will no longer be available to the

child. The child will still be a minor at the end of this five year period and therefore the funds need to be placed in the control of a guardian of the child prior to that period ending.

Applicant prays that a hearing on this Application be set; that Applicant, _____, be appointed Guardian of the Person and Estate of _____, a Minor; that the Court Order appointing _____ as Guardian be effective upon her taking the Oath and giving a bond as required by law; that upon the Guardian's qualification, the Clerk of this Court shall issue Letters of Guardianship to _____; that the Court appoint an attorney and/or guardian ad litem, if they have not already been appointed, to represent the Ward's Person and Estate; and that the Court enter any other Orders it deems necessary.
