- I. Certificate of Need Program
- A. AL2020-029, Chitto Dialysis, LLC d/b/a Imperial Home Training Dialysis, Shelby County, AL: Proposes to establish and operate a new End Stage Renal Disease (ESRD) facility comprised of three (3) new home training stations to be used alternatively for home hemodialysis training/treatment and peritoneal dialysis training/treatment in Shelby County. Opposition: None.

Approved.

B. AL2020-031, Tvilleslinvestors36 LLC, Trussville, AL: Proposes to construct a sixteen (16) bed Specialty Care Assisted Living Facility (SCALF) on property adjacent to Legacy Ridge Assisted Living in Trussville. **Opposition: None.**

Approved.

C. AL2020-032, Oaks on Parkwood, LLC d/b/a Oaks on Parkwood Specialty Care Assisted Living Facility, Bessemer, AL: Proposes to relocate twenty-two (22) Specialty Care Assisted Living Facility (SCALF) beds from Greenbriar at the Altamont, LLC d/b/a Greenbriar on Hanover Specialty Care Assisted Living Facility in Jefferson County for a total of sixty-six (66) SCALF beds. Opposition: None.

D. AL2020-034, The Haven Memory Care Facility, Gulf Shores, AL: Proposes to expand the existing facility by adding twenty-four (24) Specialty Care Assisted Living Facility (SCALF) beds to accommodate residents from their sister facilities in Foley and Fairhope, as well as other area seniors who need memory care services. Opposition: None.

E. AL2020-035, Eastchase Senior Living, Montgomery, AL: Proposes the conversion of a forty-eight (48) bed Assisted Living Facility (ALF) to a forty-eight (48) bed Specialty Care Assisted Living Facility (SCALF). Opposition: None

F. AL2020-036, Aria at Siluria, LLC, Alabaster, AL: Proposes to develop a senior living campus that will include thirty-two (32) Specialty Care Assisted Living Facility (SCALF) units, as well as thirty-two (32) Assisted Living Facility (ALF) and sixty (60) Independent Living units. Opposition: None

G. AL2020-037, WR Services, LLC d/b/a The Belmont II, Montgomery, AL: Proposes to convert the Belmont II sixteen (16) bed Assisted Living Facility (ALF) to a sixteen (16) bed Specialty Care Assisted Living Facility (SCALF). Opposition: None.

H. AL2020-038, Alabama Somerby, LLC d/b/a Brookdale University Park, Birmingham, AL: Proposes to expand by adding forty (40) Specialty Care Assisted Living Facility (SCALF) beds at its existing facility through the conversion of thirty (30) Assisted Living Facility (ALF) beds and ten (10) new beds for a total of seventy (70) SCALF beds. Opposition: None.

I. AL2020-039, Reliant Renal Care – Alabama, LLC d/b/a RRC Northridge, Northport, AL: Proposes to expand the existing twenty-four (24) station End Stage Renal Disease (ESRD) Dialysis Treatment Center in Tuscaloosa County by adding three (3) home training stations, resulting in a total of twenty-seven (27) stations. Opposition: None.

J. AL2020-040, NIC Huntsville Senior, LLC d/b/a Vitality Living at Moore Farm, Huntsville, AL: Proposes to construct a senior living campus in the City of Huntsville, Madison County, to include ninety-five (95) independent living apartments, sixty-three (63) assisted living beds, and twenty-four (24) Specialty Care Assisted Living Facility (SCALF) beds. Opposition: None.

K. AL2020-041, Rehab Associates, LLC d/b/a Rehab Associates, Wetumpka, AL: Proposes to add occupational therapy services and operate the clinic as a multi-specialty outpatient rehabilitation center. Opposition: None.

RV2020-021, **Leg Health Vascular Centers**, **Inc.**, proposes to add an office-based lab in order to perform low-risk peripheral angiography and interventional procedures, left and right diagnostic heart catheterizations - coronary angiography, elective internal cardiac defibrillator (ICD) and planned pacemaker generator changes, low-risk ICD and pacemaker implantation, implantable loop recorder insertion, direct current cardioversion, infusaport placement, transesophageal echocardiography,

pulmonary artery pressure recording devices and low-risk atrial, ventricular, and nodal ablation procedures within their private practice in Auburn, Lee County, Alabama. **Status: Reviewable**

RV2020-023, Restore Outpatient Therapy of Mobile, proposes to establish a clinic to provide physical therapy as its single service. Status: Non-reviewable

RV2020-026, inVision Ophthalmology, PC, proposes to provide office-based surgeries, including cataract surgery, blepharoplasty, minimally invasive glaucoma surgery, and pterygium excision as they are low-risk, minimally invasive and general anesthesia is not required, in Jefferson County, Alabama. **Status: Non-Reviewable**

EQR2020-002, The Children's Hospital of Alabama, proposes to replace the imaging equipment for vascular and neurological intervention radiology in Birmingham, Jefferson County. **Status: Non-reviewable**

B. Pending Reviewability Determinations

RV2020-022, Hale County Hospital, proposes to relocate their administrative office to another site in Hale County, Alabama. **Status: Pending**

RV2020-024, Alabama Home Health Care Providers, proposes to provide home health services in Etowah, Talladega, Calhoun, Jefferson, Marshall, and Madison counties in Alabama. **Status: Pending**

RV2020-025, Madison Surgery Center, proposes to undertake a construction project at its existing facility that will include the conversion of administrative space into additional operating rooms and other clinical space in Madison County, Alabama. **Status: Pending**

RV2020-027, Bio-Medical Applications of Alabama, Inc. d/b/a Fresenius Kidney Care Florence, proposes to establish a new kidney disease treatment center and operation of ten (10) stations in Lauderdale County. **Status: Pending**

RV2020-028, Techota, LLC d/b/a CV Home Health of Bibb County, proposes to open a second drop site in North Jefferson County, Alabama. Status: Pending

Rural, Cullman Regional Medical Center, proposes the re-opening of a second catheterization lab for vascular surgery and for diagnostic and interventional cardiac catheterization on CRMC's campus. **Status: Pending**

RV2021-001, Restore Outpatient Therapy Services, proposes to establish a single specialty rehabilitation agency providing a single service, physical therapy. **Status: Pending**

RV2021-002, Salame Heart & Vascular Clinic, LLC, proposes to add an office-based lab. Status: Pending

RV2021-003, The Heart Center Cardiology, proposes to perform low-risk peripheral angiography and interventional procedures, left and right diagnostic heart catheterizations - coronary angiography, elective internal cardiac defibrillator (ICD) and planned pacemaker generator changes, low-risk ICD and pacemaker implantation, implantable loop recorder insertion, direct current cardioversion, infusaport placement, transesophageal echocardiography, pulmonary artery pressure recording devices and low-risk atrial, ventricular and nodal ablation procedures within this private practice. **Status: Pending**

III. New Business

Declaratory Ruling 155: Addiction and Mental Health Services, Inc., d/b/a Bradford Health Services, submits this Petition for Declaratory Ruling that a plan by Institute for Substance Use Disorders, LLC d/b/a Sereno Ridge Recovery, to develop and operate a sixteen (16) bed, 16,500-square-foot "Clinically Managed High Intensity Residential Treatment Program for Adults and Medically Monitored Residential Detoxification Program" in Morgan County proposes a new institutional health facility and services as defined by ALA. CODE §§ 22-21-260(6), 22-21-260(8), 22-21-260(9); SHPDA Rules 410-1-2-.05(1), 410-1-2-.06, 410-1-2-.14, and § 410-2-4-.11 of the Alabama State Health Plan and is subject to mandatory CON review by the Certificate of Need Review Board.

The Board voted to dismiss the Petition for Declaratory Ruling.

The next CON Review Board meeting will be held on December 16, 2020.
