Sixth Circuit Allows Discovery In Support of DIFC Arbitration

The United States Court of Appeals for the Sixth Circuit (“Sixth Circuit”) has ruled that federal courts in the United States may order parties to produce documents and testimony in support of private commercial arbitrations overseas pursuant to 28 U.S.C. § 1782. It is the first federal court of appeal to do so, and its decision stands in conflict with prior decisions. This ruling establishes a circuit split that will eventually require resolution by the nation’s highest court. [More »](#)
