

The Bucket List Bandit Is Wanted in 9 US States for Robbery

A robbery suspect has received the name, "[The Bucket List Bandit](#)," because he told a bank teller in Utah that he only had four months left to live. Regardless of his illness, he is now wanted in nine states across the U.S., including Arizona, Utah, Colorado, Illinois, Idaho, North Carolina, Pennsylvania, Tennessee, and Missouri. While at the banks, the man hands the teller a note that says he has a gun and to give him money, however he has yet to show a weapon during any of the robberies.

A person commits [robbery](#) when they take property from another person and use or threaten to use force to obtain the property. Robbery is a class 4 felony, and is punishable by up to 3 years in prison. The Bucket List Bandit has robbed a total of 10 banks across 9 different states, which means he could face up to 30 years in prison for each robbery.

If The Bucket List Bandit were to show a weapon during any of these robberies, his charge would increase to armed robbery, which is a class 2 felony. A class 2 felony carries a prison sentence of up to 10 years for each offense. The Bucket List Bandit would face up to 100 years in prison for these robberies if he were armed at the time of the offenses.

Robbery and [armed robbery](#) are both serious offenses in the state of Arizona.
