July 10, 2012 - The U.S. Marshals along with the Wisconsin Department of Corrections Sex Offender Registry Program, the Marathon County Sheriff's

Department, and the Wausau Police Department conducted a residence verification operation for registered sex offenders. On June 26th and June 27th teams checked the addresses of 188 registered sex offenders in Marathon County. At least 6 were found to be noncompliant.
