| the motion of plaintiffs Wendell Belew and Asim Ghafoor for |
| liquidated damages against defendants in their official capacities, |
| denied liquidated damages or any other recovery to plaintiff Al |
| Haramain Islamic Foundation, Inc, granted the motion of plaintiffs |
| Belew and Ghafoor for attorney fees and expenses, denied all other |
| relief requested by plaintiffs, granted plaintiffs' request to |
| dismiss without prejudice plaintiffs' Second, Third, Fourth, Fifth, |
| and Sixth claims for relief and directed the clerk to enter |
| judgment. |

Now, therefore, IT IS HEREBY ORDERED, ADJUDGED AND DECREED AS FOLLOWS:

- 1. Plaintiffs Ghafoor and Belew shall each recover a total sum of \$20,400 in liquidated damages from defendants in their official capacities Barack H Obama, President of the United States; Keith B Alexander, the Director of the National Security Agency; Adam J Szubin, the Director of the Office of Foreign Assets Control; and Robert S Mueller III, the Director of the Federal Bureau of Investigation; and
- Plaintiffs Ghafoor and Belew and their counsel shall recover a total sum of \$2,515,387.09 in attorney

fees and \$22,012.36 in expenses from defendants in their official capacities Barack H Obama, President of the United States; Keith B Alexander, the Director of the National Security Agency; Adam J Szubin, the Director of the Office of Foreign Assets Control; and Robert S Mueller III, the Director of the Federal Bureau of Investigation.
