

#### **Banking Trojans Are On The Rise**

New banking trojans are on the rise on the Internet and are attacking conline bank accounts of The are were party programs - which wait on your hard drive for an opportunity to crack your online bank account - are different from traditional "phishing" e-mail scams that try to trick you into typing your login information at fake bank websites. They're invisible, can steal data multiple ways and require no action by the victim to be launched. A computer can be infected with a banking trojan by clicking on a link to a greeting card or video that arrives in e-mail spam. They can also be picked up by clicking to a web page that's been corrupted by hackers. There were over 59,000 unique banking trojans circulating on the Internet in 2008, up from 16,000 in 2007. The escalation partly underscores how intensively criminal hackers churn out new trojans to escape detection by antivirus programs.
