## **Airbnb and Schuyler County Reach Tax Collection Agreement**

Schuyler County Becomes Eighth New York County Where Airbnb Automatically Collects and Remits County Tax Revenue, While New York State Leaves Money on the Table

SCHUYLER COUNTY, NY - Today, Schuyler County and Airbnb announced an agreement to allow the world's largest home sharing platform to collect and remit county hotel occupancy taxes on behalf of thousands of guests who visit the county every year. The agreement, which goes into effect March 1, is expected to grow the county's tax base and allow the Airbnb community to contribute its fair share of taxes.

Schuyler Airbnb hosts cater to a range of travelers, from NASCAR fans in town for the Watkins Glen International to families looking for a comfortable place to vacation in the Finger Lakes. In 2016, the typical host in Schuyler County earned \$10,300, with many hosts using this supplemental income to start small businesses, save for retirement, repay student debt or pay their rent or mortgage..

Airbnb is also bringing new travelers to local small businesses, with hosts in Schuyler County welcoming over 3,300 guests in the last year alone.

Schuyler joins Delaware, Essex, Franklin, Otsego, St. Lawrence, Sullivan, and Tompkins Counties in entering tax agreements with Airbnb. You can find more information about the agreements reached in the seven other counties here.

Worldwide, Airbnb has collected and remitted over \$175 million in taxes in over 220 cities, states and countries, including Connecticut, Florida, Pennsylvania, Rhode Island, and Vermont. Unfortunately, New York State law prevents Airbnb from collecting and remitting taxes at a statewide level, leaving millions in potential tax revenue on the table.
