ESMA publishes updated Questions and Answers on prospectuses

On 20 December 2016, ESMA published version 26 of its 'Questions and Answers' on prospectuses. The 'Q&A' document provides information to stakeholders by responding to questions submitted by the public and competent authorities in relation to the practical application of the Prospectus Directive and its implementing measures.

The updated document includes a new question and answer (see question 101) on the application of ESMA's guidelines on alternative performance measures (ESMA/2015/1415) which came into force on 3 July 2016 (the application date). The answer clarifies how to apply the guidelines when different constituents of a prospectus (for example, the summary, the registration document or the securities note) are published on either side of the application date. In summary, ESMA confirms that the applicability of the guidelines will be determined by reference to the publication date of the prospectus.
