II. Certificate of Need Program

- A. AL2013-035-E, Tuscaloosa Rehabilitation and Hand Center, Inc., Northport, AL: The applicant requests an emergency review to relocate from 3835 Watermelon Road, Ste. E, Northport, Alabama, to 5690 Watermelon Road, Ste. 100, Northport, AL. CON 2613-REHAB-E was issued April 16, 2013.
