APRIL 3, 2007 H-1B Cap Reached on Opening Day Boston The United States Citizenship and Immigration Services (USCIS) announced today that the cap for H-1B petitions for FY 2008, which Washington begins on October 1, 2007, has been met! **New York** As of April 2, 2007, all 58,200 available H-1B visa numbers for FY 2008 have been depleted and any cap-subject petitions received after Stamford April 3rd will be rejected and returned with filing fees. Under USCIS Los Angeles regulations, petitions received on April 3rd will be included in a computer-generated random-selection process. Palo Alto The number of H-1B cases filed is staggering. USCIS claims that as of late afternoon on April 2nd, it had received approximately 150,000 San Diego cap-subject H-1B petitions. Because of this large volume, the results London of the random selection process will not be known for several weeks. As for the additional 20,000 H-1B visa numbers reserved for foreign nationals who have earned a U.S. master's or higher degree, USCIS www.mintz.com does not yet know how many of these types of petitions are mixed in with those cases already received.
