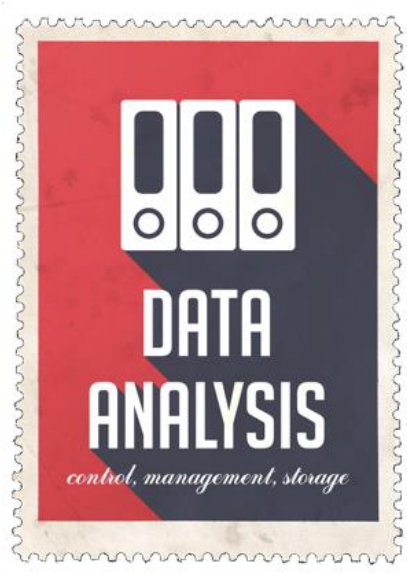


# Got Equivio?

## A Quick Reference to Highlighted Relationships



Founded in 2004, Equivio has become one of the world's leading providers of text analysis software for information governance and eDiscovery. Currently they have generated increased awareness of their offering and company based on the reported potential acquisition of the company by Microsoft (see *e-Discovery Industry Reaction to Microsoft's Offer to Purchase Equivio for \$200 Million*, [Part One](#) and [Part Two](#), by Ralph Losey).
