



I. Certificate of Need Program

- A. **AL2015-030, Lakeshore Foundation, Birmingham, AL:** Proposes to construct a two-story addition containing patient rooms, a nursing station, a day room and a lobby area. The Hospital consists of twenty (20) private rooms and forty (40) semiprivate rooms. When the project is complete, there will be sixty-four (64) private rooms and eighteen (18) semiprivate patient rooms. **Opposition: None.**

- B. **AL2015-031, Bio-Medical Applications of Alabama, Inc. d/b/a BMA of Montgomery Baptist, Montgomery, AL:** Proposes to relocate and expand its existing twenty-five (25) station ESRD Treatment Center by adding seven (7) in-center hemodialysis stations and one (1) isolation station for a total of thirty-three (33) stations. **Opposition: None.**

- C. **AL2015-032, Twenty/Twenty, LLC, Enterprise, AL:** Proposes to construct a new eighteen (18) bed specialty care assisted living facility adjacent to Kelley Place, a sixteen (16) bed SCALF. **Opposition: None.**

**RV2015-044:** Methodist Homes d/b/a Wesley Manor Retirement Center requests to renovate a portion of the existing patient rooms, create a new entrance for one (1) of the wings, upgrade certain administrative spaces and add a new 3,200-square-foot addition. **Status: Non-Reviewable**

RV2015-026: Highlands Health & Rehab requests to replace the existing 50-bed nursing home in Scottsboro, AL. **Status: Pending**

RV2015-046, Southeast Alabama HomeCare, LLC d/b/a Southeast Alabama HomeCare of Eufaula, requests to relocate their home health branch office to a new location at 335 Macon Street, Suite B, Eufaula, AL. **Status: Pending**

RV2015-047, GGNSC Bessemer, LLC d/b/a Golden Living Center-Meadowood, requests to provide outpatient physical therapy in Jefferson County. **Status: Pending**

RV2016-001, Eufaula Physical Therapy and Wellness, LLC, requests to provide physical therapy only at 335-A Macon Ave., Eufaula, AL. **Status: Pending**

RV2016-002, Gadsden Regional Medical Center, requests to construct two (2) additional operating rooms in the hospital for a total of eighteen (18) operating rooms. **Status: Pending**
