

USCIS Updates H-1B Cap Count

The United States Citizenship and Immigration Service updated its H-1B cap count

yesterday. Here are the numbers:

Regular H-1B Cap: 13,600

U.S. Masters H-1B Cap: 5,800

These filings were as of **April 15, 2010**.

USCIS Announces Revised Forms I-600 and I-600A



U.S. Citizenship and Immigration Services (USCIS) announced that it has published new versions of the *Petition* to Classify Orphan as an Immediate Relative, Form I-600 and the Application for Advance Processing of Orphan Petition, Form I-600A. The new date on the bottom of both forms is "12/30/09 N."

Due to the changes on the forms, previous versions will no longer be accepted after a *60* day transition period.

Beginning April 1, 2010 and continuing until June 2, 2010, USCIS will provide a transition period during which previous versions of the forms will continue to be accepted. **After June 2, 2010**, only the 12/30/09 version of these forms may be used.

Please note: If someone attempts to file any previous version of either form *after June* 2, 2010, USCIS will *reject* the filing. The rejected form, supporting evidence, and any filing fee will be returned with a copy of the 12/30/09 version so that the person can file using the correct form.

Prospective adoptive parents residing in the United States must continue to submit Forms I 600, I 600A, and all supporting documents to the USCIS Dallas Lockbox facility for initial processing, using one of the following addresses:

After Forms I-600 and I-600A are received at the USCIS Dallas Lockbox facility, they will be routed to and adjudicated at the USCIS National Benefits Center, in Lee's Summit, Missouri.

Prospective adoptive parents residing abroad can also file the Form I-600A or Form I-600 through the Dallas Lockbox facility.

Prospective adoptive parents residing abroad can also file the Form I-600A and Form I-600 as follows:

- Form I-600A can still be filed at the overseas USCIS office having jurisdiction over the overseas place of residence.
- Form I-600 can still be filed at the overseas U.S. Embassy, consulate or USCIS
 office having jurisdiction to accept the petition.

<u>Please note:</u> In order to file a Form I-600 petition abroad, the petitioner must have an approved and valid Form I-600A and must be physically present at the time of filing in the adoptive child's country.

USCIS Issues Q/A on H-1B 'Cap Gap' for F-1 Students

The United States Citizenship and Immigration Service (USCIS) issued an excellent Question and Answer on the H-1B Cap Gap. This Q & A addresses the automatic extension of F-1 student status in the United States for certain students with pending or approved H-1B petitions (indicating a request for change of status from F-1 to H-1B) for an **employment start date of Oct. 1, 2010** under the Fiscal Year (FY) 2011 H-1B cap.

Latest Blog: Trail of Dreams Stops in Raleigh



A few weeks ago, I had the opportunity to meet with a group of inspirational immigrant students who made a stop in North Carolina on their 1,500 mile trip from Miami, FL to Washington, D.C. by foot as part of the "<u>Trail of Dreams</u>" initiative to demand just and smart immigration reform. The event was sponsored by <u>UnitingNC</u>, an organization with a mission to foster rational dialogue between immigrants and others in the community.

North Carolina, like other southern states, has seen a significant increase in deportations, workplace raids, and barriers to higher education for immigrant students. Furthermore, Section 287(g) of the Immigration and Nationality Act, which authorizes the Federal Government to enter into agreements with state and local law enforcement agencies to perform immigration law enforcement functions, has created fear amongst aliens who lack a valid immigration status. This often causes illegal aliens to fail to report crimes to local law enforcement for fear of deportation.

These students spoke openly and candidly to me, public safety representatives and others interested community members about the challenges that these students and the 12 million undocumented aliens in the United States face each day and the hope that they have for the future. These students, some of whom are undocumented, are no different than any of us. They are good, hard-working, and kind people. The only difference is a status based on law. In the history of our great country, there have been bad laws related to women's voting rights and segregation, to name a few, and those laws have been changed. Gaby, one of the students, pointed out that we need to do the same thing with our immigration laws.
