Police said that in addition to having multiple past warrants and a known connection to gangs, the juvenile suspect is also considered to be a flight risk. In cases such as this one, where the suspect is under 18 and has a track record of criminal behavior, the suspect should seek counsel from a juvenile criminal defense attorney. There's a lot at stake when a juvenile is accused of a crime such as burglary in Arizona. Juvenile offenders need someone who can closely examine their case and provide them with strategic advice.
