Not every diagnosis that is missed will result in compensation. You will need to establish that medical negligence played a role.

In order to prove that a doctor was negligent, you will need to show that a doctor/patient relationship existed. This means the doctor owed a duty of care to you. You will then have to demonstrate that you or a loved one was seriously or fatally injured and it was the direct cause of your doctor breaching his or her duty of care. Misdiagnosis of a Brain Tumor in Cleveland

A brain tumor misdiagnosis can be especially serious. Not all brain tumors are malignant (cancerous with the potential to spread). But even a benign (non-cancerous) tumor may need to be removed in order to prevent further injury.

Of course, the most serious type of brain tumor to miss is one that is malignant. If the tumor is caught early before it can grow and spread, it could save the patient's life.

Tumors can start in the brain. But they can also start somewhere else in the body and then spread to the brain. This occurs most frequently with breast or lung cancer. However, the potential is there for other types as well.

The misdiagnosis of a brain tumor could mean a delay in treatment. This can lead to severe consequences. Or it could also mean that no treatment is administered, resulting in a fatal outcome.

Symptoms of a Brain Tumor

Detecting a brain tumor is done with imaging tests, but there are symptoms that may indicate the presence of one. Doctors who fail to recognize the symptoms, dismiss them or don't order appropriate tests could be held liable. Medical malpractice lawyers can help in gathering the necessary evidence to prove a claim.

Here are just some of the possible symptoms that may be experienced when a patient has a brain tumor:

- headaches;
- changes in behavior;
- brain damage;
- paralysis;

- vision problems (loss of, double, etc.);
- body's temperature can't be regulated;
- impaired hearing;
- fatigue;
- · cognitive dysfunction; and
- sleep disturbances.

When a patient complains of these symptoms, doctors should run appropriate diagnostic and imaging tests to determine the medical condition. Failure to do so could lead to devastating results.
