## JUDGMENTS

Victoria

30 October 2014 - Finding into Death with Inquest of Anne Christine Brain 2011 004797

Ms Brain had a complex mental health history. She suffered from schizophrenia, anxiety and depression. She was also dependent on prescription medication. In December 2011, Ms Brain passed away from intoxication by the combined effects of Tramadol, Methadone, Diazepam, Codeine, Alprazolam, Risperidone, Doxepin and Metoclopramide. That year alone, she was repeatedly prescribed the same analgesic, anti-anxiety and antidepressant medications from seven different general practitioners.

A number of doctors who had prescribed medication to Ms Brain in the lead-up to her death suggested that a real time prescription monitoring (**"RTPM"**) system – an electronic system allowing pharmacists and doctors to monitor the prescription and dispensing of medication – would have enabled them to make more informed decisions about her health care.

The Coroner noted the current absence of a Victorian RTPM system and discussed the significant potential for RTPM to prevent people from obtaining medications for non-therapeutic purposes. In view of these considerations, the Coroner strongly recommended that:

- the Victorian Department of Health urgently progress the implementation of a Victorian RTPM system;
- the scope of drugs monitored by the system be expanded beyond Schedule 8 drugs (a category of drugs prescribed by legislation); and
- the Department of Health consider meeting with private health IT developers to discuss and address any legislative and regulatory barriers that might prevent private companies providing RTPM capacity through their products and services.

These recommendations follow the recommendations of Coroners West, Jamieson, Hawkins and Heffey, who had each recommended the implementation of such a system in various findings over a number of years.

# 29 October 2014 – New South Wales Nurses and Midwives' Association v Crown in Right of the State of New South Wales (Director General, NSW Ministry of Health in respect of Sydney Local Health District) [2014] NSWIRComm 54

The New South Wales Nurses' and Midwives' Association brought a claim on behalf of two registered nurses who were members of the Association and were employed under the Public Health System Nurses' and Midwives' (State) Award.

The Association claimed that the two nurses, Ms Pink and Ms White, were entitled to, but were not paid the "In Charge of Shift Allowance" ("ICS Allowance") prescribed by the Award when they worked as team leaders on shifts in the Haemotology Ambulatory Care Unit ("HACU") at Concord Hospital.

The issue before the NSW Industrial Relations Commission related to the interpretation of the Award. In order to determine whether the nurses were entitled to the ICS Allowance, the Commission was required to consider whether the role of HACU team leader constituted "day to day clinical management for the shift" and whether that responsibility was "delegated" or "designated" to Ms White and Ms Pink.

Considering the duties performed by the team leader (including allocation of patients, management of daily nurse to patient workload and organising the admission of HACU patients), the Commission determined that the role performed by the team leader did constitute the "day to day clinical management for the shift"

for the purposes of the Award. The Commission also found that both Ms White and Ms Pink were designated to undertake the role of team leader on nominated shifts, despite the fact that this designation was not evidenced in writing. Ms White and Ms Pink were therefore entitled to the ICS Allowance.

# 28 October 2014 – *Robert Graeme West and Western Sydney Local Health District* [2014] NSWIRComm 1027

Unfair dismissal – out of time application – applicant had legal representation from the outset – pursued part 7 claim with the benefit of legal advice – respondent advised of jurisdictional hurdle – respondent offered not to raise jurisdiction argument if the applicant discontinued part 7 proceedings and lodged part 6 claim – applicant made informed decision to pursue part 7 claim to finality stating it was his preferred jurisdiction – decision in favour of the respondent – out of time claim lodged by applicant pursuant to part 6 – applicant claimed that he would have lodged a part 6 claim if the respondent had advised him of the appeal processes available to him at the time of the dismissal – applicant was not aware of the existence of a memorandum of understanding with the HSU that removed his appeal rights pursuant to part 7 – respondent obliged to advise of internal appeal processes – respondent not obliged to advise of litigation options – application was lodged out of time – delay did not result from ignorance or incapacity – no positive demonstration of hardship before the commission – no demonstration of respondent contributing to the delay in lodgement of the claim – applicant failed to discharge the onus of proof to establish a sufficient reason for the exercise of discretion.
