Welcome to the June edition of the Alston & Bird CPSC Recall Snapshot.

The U.S. Senate confirmed Dana Baiocco as a commissioner of the CPSC on May 22, 2018. President Trump originally nominated Baiocco on September 21, 2017, and some voiced concern that she was "too close" to industries for the position. However, the Senate confirmed her with a vote of 50-45. Commissioner Baiocco will serve a seven-year term, which runs through October 2024. She replaces Marietta Robinson, whose term ended in October 2017.

Also in May, the CPSC issued an abnormally large number of news releases, perhaps signaling a greater effort at public outreach under Chairman Ann Marie Buerkle's leadership. The news releases, which are <u>available here</u>, covered a variety of topics, from the CPSC urging users of ATVs to keep off roads to urging caregivers to use restraints with inclined sleep products.
