

After more than 20 years, on October 26, 2005, the European Parliament and the Council finally approved the Directive 2005/56/EC on cross-border mergers of limited liability companies.

The Directive has introduced a uniform and simplified procedure in order to pursue cross-border mergers between limited liability companies incorporated under the laws of a Member State and having their registered office, central administration or principal place of business within the Community, provided that at least two of them are governed by the laws of different Member States. Last year in Bucharest, the European insolvency practitioners association, INSOL Europe, held their annual congress. During that congress Professor Bob Wessels of the Vrije Universiteit Amsterdam and Professor Miguel Virgós of the Universidad Autonoma de Madrid presented their Public Draft of September 2006 on the non-binding European Communication and Cooperation Guidelines for Cross-border Insolvency proceedings, also known as the 'CoCo-guidelines'.

With their presentation in Bucharest Bob Wessels and Miquel Virgos were seeking to test the draft rules against the experience of the INSOL Europe practitioners. Insol Europe's Secretary General, Marc Udink, who initiated this project for Insol Europe, during the Bucharest Congress appointed a Committee Best Practices to further develop the CoCo guidelines. As secretary of this CoCo-project, I would like to inform the members of ILN and their clients of the importants of the CoCo guidelines for a better and faster cross border recovery. [FULL STORY]
