


Global Situation Update: April 13, 2021

WHAT WE'RE WATCHING

The largest volcanic eruption yet rocked the Caribbean island of St. Vincent yesterday, sending a massive cloud of ash and gas high into the sky. Heavy ash is falling in Barbados, 100 miles to the east, while ash has also reached nearby Guadeloupe, Dominica, Martinique, and St. Lucia.

With Caribbean tourism already suffering due to COVID-19, this volcano could put a further damper on the industry and negatively impact local economies.







Global

Globally, confirmed coronavirus infections topped 136.6 million with more than 2.9 million deaths.

- A large clinical study in the UK found that a widely available inhalable asthma drug,
 Budesonide, reduced the recovery time for COVID-19 patients treated at home.
- A more transmissible coronavirus variant first detected in Britain does not cause more severe illness in hospitalized patients, according to a new study published by the Lancet.



COVID-19 Vaccine

WTO Chief Okonjo-Iweala set a meeting with major manufacturers for Wednesday to discuss "glaring" vaccine inequalities.


- Globally, 805.74 million doses of vaccine have been administered.
- Sanofi announced a \$475.4 million investment over the next five years to create a new vaccine production site in Singapore.
- Five South Korean companies, SK Bioscience,
 EuBiologics, Cellid, Genexine and GeneOne Life
 Science, have launched clinical trials for new COVID-19 vaccines.
- Kingdom of Tonga receives 24,000 doses of the AstraZeneca/Oxford vaccine from the COVAX Facility.

- India approved the use of Russia's Sputnik V vaccine.
 India is to fast-track emergency approvals for COVID-19 vaccines that have been authorized by Western countries and Japan, paving the way for possible imports of Pfizer, Johnson & Johnson, Novavax and Moderna shots.
- Australia has abandoned plans to purchase Johnson & Johnson's coronavirus vaccine as it investigates another blood clot event linked to the Oxford-AstraZeneca shot, which uses similar technology known as viral vector.



COVID-19 Vaccine

According to the WHO, with the arrival of COVID-19 vaccines to Libya on April 5, all 22 countries in the Eastern Mediterranean Region have received doses. To date, over 25 million doses have been administered regionally







Markets & Business

New York's state pension fund will divest \$7 million from six Canadian oil sands firms over climate concerns.

- Global stocks edged up on Tuesday as China trade data boosted confidence for a rebound in its domestic demand.
- Bitcoin hit a record of \$62,741 on Tuesday, extending its 2021 rally to new heights a day ahead of Coinbase's initial public offering.
- Taiwan's dollar has fallen sharply on growing expectations the US will brand the Asian country a currency manipulator.
- Russia's rouble has dropped by 5 percent in the past month amid mounting geopolitical tensions, with Moscow's military build-up on the border with Ukraine and the prospect of fresh US sanctions unnerve investors.
- Microsoft has agreed to buy Nuance, a firm specializing in speech-recognition, for \$16 billion.

- Singapore-incorporated merchant commerce platform Pine Labs
 has acquired e-commerce and fintech firm Fave in a cash and
 equity deal valued at over \$45 million.
- Chinese regulators have ordered Ant Group to restructure; the company's lending services may be weakened by loosening ties to Alipay.
- Uber reported record gross bookings in March as rideshare demand rose to its highest levels since the start of the pandemic. Intel announced plans to produce microchips at its US plants in the next 6-9 months.
- United Airlines will seek to raise \$9 billion in US markets this
 week in order to repay its pandemic-related government loan.



Africa


 Vote counting is underway in **Benin** following a presidential election; incumbent President Talon looks set to win despite a week of protests against his decision to seek a second term.

Democratic Republic of the Congo President Tshisekedi unveiled his cabinet after a two
month wait, comprised primarily of pro-Tshisekedi politicians.

Twitter will establish a regional headquarters in Ghana.

 The governments of Tanzania and Uganda signed a deal with France's Total and China's CNOOC to establish a major east African oil pipeline.

Leaders at the South African Development Community pledged an immediate "technical" intervention in Mozambique and to prepare for military intervention to quell the Islamist uprising in Cabo Delgado.





Asia

- Philippine President Duterte made his first public appearance in two weeks on Monday, heading off rumors about his potential ill health and even death.
- Thailand reported a second consecutive daily high of 985 cases as the country's third wave continues.
- India has banned the export of Remdesivir amid its record surge of COVID-19 cases.
- Japan will release more than 1 million tons of contaminated water from the destroyed
 Fukushima nuclear station into the sea, a move opposed by neighbors including China, which called it "extremely irresponsible." Japan started vaccinating elderly people, the second priority group after health workers.
- Taiwan reported the largest incursion yet by the Chinese air force in its air defense identification zone, which included 25 aircraft and nuclear-capable bombers. The move comes after the US State Department issued new guidelines Friday making it easier to meet with Taiwanese officials. China's President Xi is expected to take part in President Biden's two-day virtual climate summit next week. Hong Kong Chief Executive Carrie Lam said that people who have been vaccinated can form "vaccination bubbles" and gather in larger numbers.




Europe


- The **EU's** defense chief warned that the coronavirus pandemic has weakened the ability of militaries to respond to security threats, calling for a greater focus on technology and expanding international maritime co-operation.
- **UK** trade with the **EU** partially recovered in February from sharp falls in January when Brexit border controls were introduced, and the coronavirus wave was at its peak but remained below normal levels.
- In **Germany**, the two parties of Angela Merkel's center-right coalition endorsed rival candidates for Chancellor in September elections, casting doubt on who will succeed Merkel. The Christian Democratic Union is backing party leader Armin Lashet, while the Bavarian CSU is backing Bavaria's prime minister, Markus Söder.
- Russia warned the US to ensure its warships stayed well away from Crimea "for their own good," calling their deployment in the Black Sea a provocation designed to test Russian nerves. Two US warships are due to arrive in the Black Sea this week amid an escalation in fighting in eastern Ukraine where government forces have battled Russian-backed troops. NATO Secretary-General Stoltenberg called on Russia to withdraw troops Moscow is massing on Ukraine's borders.
- Austrian health minister Anschober announced his resignation in a tearful press conference citing death threats and two collapses related to overwork.
 The UK opened vaccinations to everyone over 45 in the drive to inoculate as much of its population as quickly as possible. In the past fortnight, Poland has recorded 989 cases per 100,000 inhabitants, the third highest figure in the EU.



Europe

New variants of the coronavirus in Turkey have accelerated the spread of infections and are making people sicker, per the health minister, as the number of new cases outpaces the rest of Europe. Turkey registered more than 50,000 daily new cases for the past 6 days.

Middle East


 Iran said it will suspend human rights talks with EU countries after the bloc sanctions on several Iranian officers for human rights abuses took effect on Monday.

 In a letter to the UN, Iran called Israel's rumored cyberattack on its Natanz facility a "war crime" and called for Israel to be held accountable. The US denied any involvement.

 The Organization for the Prohibition of Chemical Weapons published a new report finding that the Syrian Air Force dropped a chlorine bomb on Idlib in 2018.

 Naftali Bennett, head of the right-wing Israeli party Yamina, said he would join a coalition headed by Prime Minister Netanyahu, who is currently seeking to build a coalition.

- Turkey and Libya re-committed to a 2019 maritime border demarcation accord after new Libyan Prime Minister Debeibeh met with Erdogan in Ankara.
- **Somalia's** parliament extended the Somali president's term by two years after negotiators failed to agree on a date or procedure for delayed elections.



Americas

- La Soufriere volcano on Saint Vincent continued to erupt on Monday, issuing its
 largest explosion yet since volcanic activity began late last week. There were no
 immediate reports of injuries or death, but roughly 16,000 people have been evacuated.
- Canada canceled permits allowing the export of military goods to Turkey after a review
 finding that Turkey illegally transferred Canadian technology to Azerbaijan during the conflict
 in Nagorno-Karabakh.
- Ontario closed in-person school due to rising COVID-19 numbers. Doctors in Ontario said they may
 soon have to decided who does and does not receive treatment as ICUs are filled with COVID-19
 patients. Canada's daily new coronavirus infections over the past 10 days have exceed 10,000
 three times, reaching highs not seen since early January.
- The White House said that **Mexico** has doubled its detentions of migrants with a 10,000 strong troop deployment on its southern border. A WHO-commissioned study has found that Mexico could have avoided 190,000 COVID-19 deaths through better management of the pandemic.



Americas: US

- More than 120 million Americans have now received one or both doses of a COVID-19 vaccine. Health officials are finding that the latest wave of US COVID-19 cases is largely driven by young people, with case rates for youth under 19 at a record high. College students are being asked to forgo coronavirus vaccines to take part in a massive study across 20 universities to see if vaccines block transmission, allowing people to finally abandon masks. The US is so well supplied with vaccines that it is unlikely to need the Oxford/AstraZeneca vaccine, per Dr. Fauci. About a quarter of adult Americans say they are not planning on getting vaccinated against the coronavirus, according to Economist-YouGov polling released last week.
- The CDC urged **Michiga**n to tighten COVID-19 restrictions as the state faces a rapid rise in cases. New York state dropped quarantine requirements for international travelers who are not showing symptoms of COVID-19.
- The **US budget deficit** jumped to a record \$1.7 trillion for the first half of fiscal year 2021, boosted by the Biden Administration's \$1.9 trillion stimulus package. It is the third-largest monthly deficit on record.
- The police chief of a Minneapolis suburb said that an officer's "accidental discharge" killed a young Black man during a traffic stop over the weekend; protests over the killing have drawn hundreds.



Nation-State Hacking Increasingly Threatens Business

In this era of heightened geopolitical tension and widespread work-from-home arrangements, nation-state cyberattacks are increasing. State-backed hackers, around for several decades now, are striking a more diverse range of targets and achieving objectives without being caught or kicking-off kinetic military action.

Just this past weekend, for example, Iran's Natanz nuclear facility was again struck by what appears to be a cyber operation, which reportedly did more damage than any conventional bomb. While this attack made world headlines, the public rarely hears of the vast majority of nation-state hacks or that, today, business is at the top of the ever-expanding list of targets. Enterprises around the world should expect to confront more sophisticated state-sponsored hacks as there remains no international agreement covering cyberwarfare and few consequences for perpetrators compared to many successes.

Recent Trends

Over one-third of recent nation-state cyberattacks have struck businesses, according to a newly released study sponsored by HP. Private enterprise has suffered more hacks than media, governments, universities, and critical infrastructure. This is due, in part, to efforts by state-backed hackers to steal intellectual property related to COVID-19 research and vaccines during the pandemic. They used proven tactics first tested by cyber criminals and are now compiling lists of zero-day vulnerabilities, or software security flaws with no patches, for future attacks against companies and

institutions. Just this week US Federal Reserve Chairman Jerome Powell expressed his concern that a critical cyberattack on American banks, likely by a state actor, now represents the biggest risk to the US economy. The SolarWinds hack, dubbed the largest and most sophisticated cyber-attack the world has ever seen, should serve as a wake-up call that nation-states view certain private companies with important clients such as governments and militaries as a gateway to their ultimate targets. The massive state-backed supply chain attack enabled by hacked software impacted tens of thousands of companies, but the actual number of targets was likely just a dozen key US government agencies and blue-chip businesses. Leaders of businesses with similarly sensitive customers can be assured that certain foreign governments are currently plotting how to penetrate them or vulnerable targets along the supply chain.

Tactics for Targeting Business

Over half of all recently recorded nation-state cyberattacks involved low-budget tools used for surveillance. Incidents of nations eavesdropping and spying on corporations and their leaders and clients are much more frequent than spectacular attacks such as the latest strike on Iran's uranium enrichment centrifuges and the 2012 Shamoon attack on Saudi Aramco that wiped over 30,000 company computers, both of which involved sophisticated, custom-made weapons developed in a state cybersecurity labs.

More often than not, cyber operatives with official backing aim to steal information that will give their patrons a competitive edge in the marketplace or extract money from victims. Even those from the poorest nations can nowadays purchase tools on the Darkweb to exploit the devices of executives and employees and learn what competitors are doing. With inexpensive hacking tools, they can steal information and ideas, or demand cash transfers or cryptocurrency to help sustain unsavory regimes or impoverished local economies. A growing trend for countries that lack certain capabilities is the recruitment of cybercriminals to conduct online attacks. Whether rich or poor, state actors choose to achieve their goals by releasing internal emails and sensitive pictures that shame and embarrass businesses. In 2014, Sony Pictures suffered such an attack when a country that did not like the movies it was producing released troves of company data and embarrassing emails to the world.


What Lies Ahead

All data indicates that the rise in state-sponsored attacks is likely to continue and strikes on business will be more prevalent in the future. Nation-state cyber budgets are increasing over time and countries, friendly and adversarial, are building armies of hackers dedicated to offensive operations. This comes as many business are slowing down increases to IT security spending due to lost revenue as result of the coronavirus pandemic. And, again, behind all these trends is the lack of globally agreed upon cybersecurity and cyberwarfare standards and ever more advanced cyber weaponry. Thus, it would be wise for today's business leaders to stay ahead of the evolving threat landscape by preparing like a nation-state is targeting them.


As of 2100 hours US EDT on April 12, 2021






