This is Akin's newsletter on climate change policy and regulatory developments, providing information on major climate policy headlines from the past week and forthcoming climate-related events and hearings:

National

• Granholm Says LNG Pause Will End Within a Year (E&E News)

Energy Secretary Jennifer Granholm noted that the "Department of Energy's [(DOE)] pause liquefied natural gas exports will wrap well within a year."

• Federal Court Halts SEC Climate Reporting Rule (Politico)

The 5th U.S. Circuit Court of Appeals obliged "two fracking companies that have asked for an emergency stay of the 'expansive and novel requirements' that they say the Securities and Exchange Commission's [(SEC)] has imposed on them" through the SEC's new climate disclosure requirement.

• House Schedules First Hearings on Final SEC Climate Rule (E&E News)

The House Financial Services Committee is holding a hearing with the aim to "discredit the [SEC's] recent rulemaking requiring major companies to disclose their climate impacts."

• House Republicans Release Details for 'Energy Week' (E&E News)

The House GOP is slated to "take up six energy-related bills and resolutions for what Republican leaders are calling 'energy week,' which includes attacking President Joe Biden's 'radical, anti-energy agenda.'"

• CERAWeek Begins: Cue the Gas Debate (E&E News)

CERAWeek—comprised of traditional energy leaders and government officials—"will focus this year on the global challenges to meeting emission reduction goals amid evolving energy markets, growing demand for fossil fuels, and geopolitical tensions like the Russia-Ukraine war."

State and Local

• 24 States Sue Over EPA Methane Rule (E&E News)

Twenty-four attorneys general in red states filed a lawsuit against the Environmental Protection Agency (EPA) and its "new rule to limit methane emissions from the oil and gas sector," citing EPA's overstep in authority.

• Arizona's Biggest Battery System Starts Up (E&E News)

The Sonoran Solar Energy Center is now operational, pairing "a 260-megawatt solar facility with a 1,000-megawatt-hour battery storage system."

• Youngkin Doubles Down on Axing RGGI (WVTF)

In response to Virginia Democrats' efforts to re-enter the Commonwealth to the Regional Greenhouse Gas Initiative (RGGI), Gov. Glenn Youngkin (R-VA) "again railed against a multistate compact aimed at reducing the impact of climate change."

Josh Shapiro Proposes State Climate Program to Replace RGGI, and Asks For New Renewable
<u>Energy Goals</u> (State Impact)

Gov. Josh Shapiro (D-PA) "is offering his own version of a controversial program to limit climatewarming pollution from power plants, and is setting new goals for how much energy Pennsylvania gets from renewable sources."

International

• Pressure Builds for Charge on Global Shipping Sector's CO2 Emissions (Reuters)

With the International Maritime Organization's (IMO) discussions underway, the "European Union [(EU)], Canada, Japan, and climate-vulnerable Pacific Island states are among 47 countries rallying support for a charge on the international shipping sector's greenhouse gas emissions."

 UN Weather Agency Issues 'Red Alert' on Climate Change After Record Heat, Ice-Melt Increases in 2023 (Associated Press)

The World Meteorological Organization's State of the Global Climate report detailed "record-smashing increases last year in greenhouse gases, land and water temperatures and melting of glaciers and sea ice," and cautioned that efforts to counter climate change may be inadequate.
