- **RE:** Amounts due to commercial agents upon termination of the relationship

The issue of termination packages for commercial agents at the end of the relationship, is governed by Article 1751 of the civil code, which has implemented the EU Directive on commercial agents (86/653/CEE) as well as by collective agreements entered into by and between the trade associations and the unions.

The position of the unions has been that of distributing the indemnity irrespective of merit, and the relevant agreement was found to be illegal by the Court if Justice. The current agreement, backed by the Italian court decisions, now dictates that a certain amount is due in all cases, irrespective of whether the agents increased sales, and an additional amount may be due if the agent meets the requirements of the EU Directive, as implemented in Italy, In all cases, the overall amount cannot exceed the one year threshold.
