Ian Victor Kincheloe Indicted on Federal Child Sex Charges

The U.S. Immigration and Customs Enforcement (ICE) on September 2, 2011 released the following:

"Orange County man indicted on federal child sex charges

Defendant used telephone and Internet to attempt lure teenage girl to Huntington Beach pier

SANTA ANA, Calif. — An Orange County man was ordered held without bond Friday following his arrest on federal charges that he attempted to lure a 13-year-old girl to the Huntington Beach pier to engage her in illegal sexual activity.

Ian Victor Kincheloe, 25, of Laguna Hills, Calif., was arrested Thursday by investigators from U.S. Immigration and Customs Enforcement's (ICE) Homeland Security Investigations (HSI) and the Orange County Sheriff's Department (OCSD). Kincheloe is accused in a federal indictment handed down Wednesday with using the Internet and telephone to attempt to entice a minor into illegal sexual activity. The charge carries a mandatory minimum sentence of 10 years in prison and a maximum sentence of life.

Kincheloe first came under suspicion in July when an investigation by the Orange County Child Exploitation Task Force revealed he had communicated in an Internet chat room with "Cindeed8400," whom he believed was a 13-year-old girl. "Cindeed8400 was, in fact, an adult posing as a minor. Kincheloe continued to communicate with "Cindeed 8400 throughout early August via the Internet, text messages and telephone calls, where he discussed in detail the illegal sexual activities he desired to engage in with her. "Targeting sexual predators is a top priority of the Justice Department, as demonstrated by a record number of offenders brought to justice in recent years," said United States Attorney André Birotte, Jr. "My office is fully committed to investigating and prosecuting individuals intent on using the Internet to prey upon young people. The children in our communities and their parents should know that we are fully committed to protecting the future leaders of this nation."

Kincheloe was initially taken into custody August 3 on state charges by the Child Exploitation Task Force at the Huntington Beach Pier, where he had arranged to meet "Cindeed8400 in person. A search of his vehicle at the scene revealed a box of condoms, alcohol and flex cuffs. Agents also determined Kincheloe had booked a room at a hotel in Newport Beach, Calif., for that night. Kincheloe was free on \$100,000 bond stemming from the state case when he was taken into custody Thursday.

"For most people, criminal acts against children are impossible to comprehend, but for the children who have been sexually exploited, these crimes are all too real," said Joseph Macias, assistant special agent in charge of ICE HSI in Orange County. "The physical and emotional scars are difficult, if not impossible, to

outgrow. As part of the Orange County Child Exploitation Task Force, ICE HSI will continue to work collaboratively to bring child molesters and online predators to justice."

"This indictment demonstrates the success

of the partnership we have forged with ICE Homeland Security Investigations to protect our children through the Child Exploitation Task Force," Orange County Sheriff Sandra Hutchens said. "Taking predators who target children off the street is what the task force is all about." Investigators believe Kincheloe may have preyed on other underage victims, who have yet to be identified. The Child Exploitation Task Force encourages the public to report suspected child predators and any suspicious activity through ICE's toll-free hotline at 1-866-347-2423.
