

California Judicial Council proposes revisions to civil jury instructions

February 5, 2016

The California Judicial Council Advisory Committee has proposed a number of revisions to California Civil Jury Instructions. A complete version of the proposed revisions is available here.

Public comments are due by March 4, 2016.
