**4. Emergency Aid Exception Permitted the Police to Act:
State v. Hathaway NJ 2015 (A-69-13)**

Viewing the events as they appeared to an objectively reasonable police officer, and based on the evidence presented by the State at the suppression hearing, the police acted within the scope of the emergency-aid exception to the

warrant requirement, and the gun should not have been suppressed.

5. Automatic rejection for PTI was Improper: State v. Roseman and Lewin NJ 2015 (A-105)

Defendants have demonstrated extraordinary circumstances to overcome the presumption against Pretrial Intervention (PTI) for second-degree offenses and there is no factual justification for the application of the factors set forth by the prosecutor under N.J.S.A. 2C:43-12(e). Denial of defendants applications to Pretrial Intervention (PTI) by the prosecutor was plainly a patent and gross abuse of discretion.
