**Statute of Limitation**: N.C.G.S. § 1-52. Three years.

Upon a contract, obligation or liability arising out of a contract, express or implied

Fraud – cause of action shall not be deemed to have accrued until discovery by aggrieved party

N.C.R.C.P. Rule 58. Entry of Judgment (serve copy of judgment on defendant)

Deadline for Appeal. Rule 3 f the Rules of Appellate Procedure (within 30 days)

The Exemption Process (Defendant is an individual) – N.C.G.S. § 1C-1601 et seq

Execution on the Judgment – N.C.G.S. § 1-302 et seq

Sheriff's Demand Documents served on Corporate Agent - N.C.G.S. §§ 1-324.2, 1-324.4

#### **Supplemental Proceedings**:

Examination of Judgment Debtor before the Court - N.C.G.S. § 1-352

Motion before Court to order Debtor to produce documents - N.C.G.S. § 1-352.2

Motion to Show Cause - N.C.G.S. § 5A-23 (Proceedings for civil contempt)

## Claim and Delivery (for recovery of personal property subject to secured / leased interest:

Ten Days Notice - N.C.G.S. § 1-474.1

Bond - N.C.G.S. § 1-475

#### Attachment:

Nature of attachment – preliminary execution against property - § 1-440.1

Grounds for attachment - § 1-440.1 (nonresident, foreign corporation, intent to defraud)

#### Garnishment:

Nature of garnishment – debtor's property in possession of third party, such as bank - § 1-440.21

### Uniform Enforcement of Foreign Judgments Act: - § 1C-1701 et seq

Filing / Notice - §§ 1C-1703, 1C-1704

Defenses - § 1C-1705 (Motion for Relief / Notice of Defenses)
