On October 5, 2012, a revised U.S. Patent Office fee schedule will go into effect. As shown in the table below, the fees effective October 5, 2012 reflect slight increases for the filing of utility applications, payment of issue and maintenance fees, appeals, and extension fees.

A much more significant change to the Patent Office fees will take place early next year. Section 10 of the America Invents Act (AIA) granted the USPTO the independent fee-setting authority after accepting public comment. Acting under this authority, the USPTO published proposed fee increases on September 6, 2012 and is accepting public comments through November 5, 2012. The new fee structure will likely be implemented in February 2013. While the USPTO has touted the proposed fee changes as representing a 22% <u>decrease</u> in the routine fees to obtain a patent,<sup>1</sup> the below table illustrates that many of the proposed fees represent a significant <u>increase</u> in government fees from the October 5, 2012 fees.
