It saddens me when I read articles like this - I can only imagine the good families that are being torn apart because of something as arbitrary as a Government quota. We are talking about people losing families and livelihoods here. This has to stop and only smart immigration reform can do it.

CSC Practice Pointer on I-129 Work Locations

The California Service Center (CSC) recently provided a pointer on how employers and attorneys should complete the section of Form I-129 that asks for the number of employees. While the I-129 form only asks for the full number of employees at the company in Part 12, CSC recommends that you list the number of employees on-site versus off-site as separate figures. For example, the section could be completed as "70 in US, 12 at worksite."

CSC adjudicators have used public sources such as Google Earth to confirm information. If

the petition states that an employer has 82 employees but the office space is only 2000 square feet, it presents an obvious inconsistency that could result in a Request for Evidence (RFE). By listing the number of employees in this manner, an employer could perhaps prevent an RFE on this issue.

Immigration Tip: AC21 Portability Letter

Under AC21, an employee can 'port' to a new employer and retain their 'green card' application if their 1) I-140 has been approved, 2) I-485 adjustment has been pending for over 180 days, and 3) new job is the same or similar to the one listed in their labor certification or I-140 application.

We have often been asked whether the new employer should proactively send an employment confirmation letter confirming the above to the United States Citizenship and Immigration Service (USCIS.) This is often known as the AC21 portability letter.

We believe that it is always good practice to send this letter to the USCIS once employment has been changed. The Texas Service Center (TSC) recently said that although there is not an affirmative requirement to provide such notification to USCIS, if you want to provide an AC21 letter confiming change of employment to send the letter to the I-485 post office box address at TSC: P.O. Box 851804, Mesquite, Texas 75185-1804.

Greece Joins Visa Waiver Program

Department of Homeland Security (DHS) Secretary Janet Napolitano announced the designation of Greece as a member of the Visa Waiver Program (VWP). As a part of the VWP, Greek citizens will be permitted to travel to the United States for up to 90 days without obtaining a visa.

With this announcement, Greece joins the 35 nations already participating in VWP— established as a pilot program in 1986 to help eliminate unnecessary barriers to travel, and made permanent on October 30, 2000. Like VWP travelers from other countries, Greek citizens will be required to apply for an Electronic System Travel Authorization (ESTA) through the Web-based system. Greek citizens will be able to visit the United States without visas in approximately 30 days.
