## DUI

In the state of Arizona, it is illegal to be in the control of a vehicle while under the influence of drugs, alcohol, or other toxic substances.

According to <u>A.R.S. 28-1381</u>, should an individual decide to operate a vehicle with a B.A.C. (blood alcohol content) of .08 or higher, they could be found guilty of a class 1 misdemeanor. If the individual has a B.A.C over .15, they could face charges of an <u>extreme DUI</u>.

When determining the penalties for a <u>DUI</u>, many things are taken into consideration, including if it is a first offense.

Jail Time	24 hours – 10 days	30 days-90 days	Minimum of 4 months
Base Fine	\$250	\$500	\$750
License Suspension	90 days – 360 days	1 year	1 year
