Their challenge seems to go more to the merits of claims based on the ICC and Swisscom transactions than whether there are common questions in the claims of all class members, and, given that the relevant Swisscom disclosures came in the middle of disclosures related to ICC, it does not seem appropriate or practical to attempt to define subclasses based on each transaction. There is no evidence that any particular potential class members are situated such that subdivision of the class would be appropriate. Class
