

### I. SHPDA Administrative Report

This project was put on the agenda for informational purposes only. No vote was required because "the recommended order of the Administrative Law Judge becomes the final order of the Agency when no exceptions have been filed." No exceptions were filed.

# **Contested** Case

AL2012-002, Regency Healthcare and Rehabilitation Center, Huntsville, AL: As originally filed, Regency Healthcare and Rehabilitation Center's application proposes to purchase and relocate 46 nursing home beds from Magnolia Trace to its current campus and to construct a new 106-bed replacement facility. The new facility would replace the existing 60-bed facility at Regency Retirement Village, operating as Regency Healthcare and Rehab, and add the 46 beds transferred from Magnolia Trace. Administrative Law Judge Terry Butts issued an order adopting a proposed settlement agreement through which 30 of the 46 beds would be transferred to Regency Healthcare and Rehab and 16 beds would be transferred to Intervenor Redstone Military Retirement Association.

#### II. Certificate of Need Program

AL2012-022, The Jacobs House, Inc. d/b/a The Jacobs House III, Hayden, AL: Proposes to A. establish an eight-bed Specialty Care Assisted Living Facility adjacent to an existing 16-bed Specialty Care Assisted Living Facility in Blount County. Opposition: None

Approved.

### Β. **Contested** Case

AL2011-033, Foley Hospital Corporation d/b/a South Baldwin Regional Medical Center, Foley, AL: Proposes to expand the hospital's cardiac catheterization services (currently provided by the hospital in one cardiac cath lab) by performing cardiac catheterization procedures in a second, existing catheterization procedure room currently being used to provide vascular catheterization and other special procedures. Opposition: Gulf Health Hospitals, Inc. d/b/a Thomas Hospital filed intervention/opposition and requested a Contested Case Hearing. The Administrative Law Judge filed his Recommended Order of approval. Thomas Hospital filed Exceptions to the Administrative Law Judge's Recommended Order.
