

WHAT WE'RE WATCHING

Evacuations of homes and businesses continue today in the Tampa Bay area as officials race to drain a wastewater reservoir at risk of imminent collapse, threatening other adjacent wastewater reservoirs.

The greatest threat posed by the damaged Piney Point reservoir is a potentially 20-foot wall of wastewater that could crash down on local residents if there is a full breach of the plastic lining. A breach would also have yet unclear impacts on the environment.







Global

US Treasury Secretary Yellen called on countries around the world to join the US in supporting a global minimum corporate tax rate.

- World Bank President Malpass said he expects G20 countries to extend their pandemic-driven freeze in bilateral debt service payments (the G20 Debt Service Suspension Initiative or DSSI) through the end of 2021.
- In a report published in the Proceedings of the National Academy of Sciences, research found that the total number of open-water species declined by about half in the 40 years up to 2010 in tropical marine zones worldwide.
 During that time, sea surface temperatures in the tropics rose nearly 0.2 degree Celsius.



COVID-19 Vaccine

Mass vaccination against the coronavirus could help tame the pandemic not only by protecting those who are inoculated but by shielding unvaccinated individuals as well, according to a new study by Israeli researchers.


- French COVID-19 vaccine Valneva manufactured in Scotland has reported positive early results in stage 1/2 trials and has given the UK government a potential domestic supply of a shot that could be used as a booster or to tackle virus variants. The French vaccine maker plans to start large late-stage trial this month.
- India's Panacea Biotec has agreed to produce 100 million doses of Russia's Sputnik V vaccine annually, per the Russian Direct Investment Fund, which did not specify when production would begin.
- Colombia will allow the private importation of COVID-19 vaccines, but the shots must be free for those being inoculated, per the Health Ministry.

China is offering its citizens incentives, including free food, to ramp up a flagging vaccine drive that aims to inoculate 40 percent of its enormous population by June.







Markets & Business

The cryptocurrency market capitalization hit a record peak of \$2 trillion, per data from CoinGecko and Blockfolio, with Bitcoin accounting for \$1.1 trillion.

- World stocks hit record highs on Tuesday, supported by strong economic data from China and the US.
- US stocks surged to close at new record highs on Monday after a report showed that growth in the US services sector accelerated by its fastest pace on record in March.
- The US Supreme Court ruled in favor of Google in a copyright landmark case, saying that it did not break the law by copying Oracle's Android code.
- The US National Labor Relations Board found that Amazon illegally fired two workers who criticized working conditions during the pandemic.
- Goldman Sachs is reportedly preparing to return hundreds of staff to its London offices this week.

- **Southwest Airlines** has recalled 209 pilots from a voluntary extended leave program to prepare for its summer schedule.
- The French government will contribute up to €4 billion to strengthen Air France-KLM's balance sheet, making it the largest shareholder.
- Credit Suisse will take a 4.4 billion Swiss franc (\$4.7 billion)
 hit from dealings with Archegos Capital Management and
 will overhaul the leadership of its investment bank and risk
 division.
- Digital payments company **Stripe** announced the opening of an office in Dubai, the UAE's financial capital, its first expansion into the Middle East region.



Africa

- Mozambique's military said that has regained full control of the coastal town of Palma, 12 days after ISIS-affiliated Islamist militants invaded.
- Canadian pop star The Weeknd donated \$1 million to the World Food Program work in Ethiopia, drawing international attention to the humanitarian situation in Tigray.
- The UN said that at least 40 people have been killed since Saturday in West Darfur tribal clashes.
- More than 1,800 inmates escaped from a Nigeria prison in the southeastern city of Owerri after
 an attack by gunmen carrying rocket-propelled grenades, machine guns, explosives and rifles.
 Nigerian police believe a banned separatist group, the Indigenous People of Biafra, was behind
 the attack, but a spokesman for the group denied involvement.
- Authorities in Ghana are investigating the cause of death for large numbers of dolphins and fish that have been washing up on beaches near Accra since Friday.



Asia

North Korea has withdrawn from the Tokyo Olympics because of the pandemic, ending an opportunity for South Korea to use the event to improve inter-Korean relations and revive nuclear talks.

 Starting next month, Singapore will become one of the first countries to adopt COVID-19 digital travel passes.

• **New Zealand** will allow quarantine-free visits by Australians from April 19.

• China reported its highest daily case count in over two months, with a city near the border with Myanmar accounting for all new locally transmitted cases.

• India's factory activity grew at its weakest pace in 7 months this March, as renewed lockdown measures cut into economic recovery. New Delhi has announced a night curfew as it seeks to check a surge of new coronavirus infections.

- China's Foreign Minister Wang and Japan's Foreign Minister Motegi had a 90-minute phone call in which Motegi expressed "strong concern" about China's incursions into territorial waters, as well as the situations in Hong Kong and Xinjiang; Wang warned Japan against joining western allies in human rights sanctions against China.
- Opponents of **Myanmar's** military junta sprayed red paint on roads in the country's biggest city on Tuesday to mark the deaths of hundreds of "martyrs" killed by troops. **China's** Foreign Minister Wang Yi warned ASEAN to be on the watch for unnamed "external forces" interfering in Myanmar. ASEAN chair Brunei announced support for a regional leaders' meeting to discuss Myanmar and directed officials to begin preparations to meet in Jakarta.

Europe

- Inflation in Turkey accelerated for the sixth consecutive month in March.
- A pro-Kremlin Russian newspaper reported that opposition activist Alexey
 Navalny has been moved to a sick ward and tested for COVID-19. Russian
 police stepped up security at the prison holding Navalny on
 Tuesday as his supporters prepared to stage a protest outside the
 facility to demand that authorities give him proper medical care.
 President Putin signed legislation that allows him to remain in office
 through 2036. The US State Department asked Russia to explain "provocations" on its border with Ukraine.
- UK Prime Minister Johnson announced a further easing of lockdown measures from April 12 and said that the UK would not introduce COVID-19 certification passports before May 17. France's health minister said the country expects COVID-19 hospitalizations to keep rising for at least another 2-3 weeks. Germany announced a goal of vaccinating 20 percent of its population by the end of April, which would mark a significant acceleration for a vaccination campaign that has taken three months to vaccinate 10 percent of the country. Spain's health ministry, noting the easing of virus outbreak, is anticipating an increase after the Easter holidays; the UK variant has become the dominant strain in Spain, in excess of 70 percent in 11 of Spain's 17 autonomous regions. Belgium surpassed 900,000 virus infections.



Middle East

 The US and Iran will begin indirect talks in Vienna today on the Iran nuclear deal. The US on Monday said it expects talks to be "difficult" and does not foresee any breakthrough.

 Israel's President Rivlin is set to announce a candidate today to try to form a new government, following consultations with political parties.

• Oman will tighten COVID-related entry restrictions and extend business restrictions in preparation for Ramadan.

Jordan's royal court said that Prince Hamzah, the former Crown Prince accused of plotting to destabilize the Kingdom, has pledged loyalty to King Abdullah. Jordanian intelligence had been monitoring the plot and intercepted "communications with foreign parties over the right timing to destabilize Jordan."

 UAE-facilitated backchannel talks between Pakistan and India seek a moratorium on fighting in Kashmir. Pakistan and India have fought three large conflicts since independence in 1947, with Islamabad maintaining that Muslim-majority Kashmir should be liberated from New Delhi's rule.



Americas

- Mexico's President Lopez Obrador said he will not get vaccinated, after doctors told him he still has high levels of COVID-19 antibodies after contracting the virus.
 Central bank data showed that remittances to Mexico hit a record high in February.
- Russia's President Putin called Argentina's President Fernandez, who has tested
 positive for COVID-19 after receiving the Sputnik V vaccine; the readout said that thanks
 to Sputnik V, Fernandez only suffered mild symptoms.
- The World Bank has approved \$150 million in additional financing for a Covid-19 emergency response project in **Ecuador**.
- Venezuela has created a special military unit for an area on its border with Colombia that has been the center of clashes between troops and illegal armed groups since last month. The fighters include fighters include dissident FARC guerrillas who reject a 2016 peace deal with the Colombian government, struggling for control over drug trafficking routes.



Americas: US

- The Biden Administration named former USAID coordinator Gayle Smith as the State Department's coordinator for global vaccine diplomacy efforts.
- Nationally, 107.5 million people have received one or more vaccine doses, 32.4 percent of the total population.
 All Maryland residents 16 or older will be eligible to receive a coronavirus vaccine at the state's mass vaccination sites starting today. Virginia will open vaccinations to the general population by April 18, and the District of Columbia. moved up the mass eligibility date from May 1 to April 19.
- The CDC warned that young people are disproportionately driving the rise in US COVID-19 case numbers and urged
 Americans not to return to normal life just yet. The CDC said that the relative risk of a person becoming infected with COVID-19
 through contact with contaminated surfaces or objects (fomites) "is considered low," at a chance of less than one in 10,000.
 Montana Gov. Greg Gianforte (R) has tested positive for the coronavirus and will quarantine for 10 days.
- The US **services sector** saw record growth in March. **US bankruptcies**, both consumer and commercial, also rose in March, in a potential sign that a pandemic backlog of bankruptcy is beginning to be cleared.
- Senate Minority Leader McConnell (R-KY) threatened "serious consequences" for companies that protest Republican voting laws in a statement Monday. Governor Hutchinson vetoed legislation that would have made Arkansas the first US state to ban gender confirming treatments or surgery for transgender youth.
- US border agents in recent months arrested two Yemeni men on a terror watchlist in separate incidents as they crossed the border with Mexico illegally.

Emerging & Existing Hotspots: Russian Troop Buildups & Alexey Navalny

Moscow is seeking to move itself up the list of foreign policy priorities for President Biden, as recent events in eastern Ukraine, Crimea, and within Russia itself have raised alarms from Washington to Brussels. The most pressing issues include the unscheduled, off-cycle buildup of Russian troops along the border with Ukraine and in Crimea, as well as a dramatic increase of cease-fire violations in Ukraine's eastern territories controlled by Moscow-backed separatists.

Social media posts from within Russia show streams of tanks, trains, and convoys streaming to the border with Ukraine and Crimea, and Russian military leaders have themselves confirmed the unusual movements in post-facto justifications saying they simply reflect "exercises." Meanwhile, NATO has simultaneously reported an "unusual peak" in Russian flights near the alliances' border, with 10 flights intercepted by NATO places within a six-hour period last Monday. The coordination of Russian ground and air military movements is not viewed as a coincidence by security officials in the US or Europe, who have engaged in series of high-level communications to discuss the matter, including an unscheduled first call between Ukrainian president Volodymyr Zelensky and President Biden on Friday. US European command and NATO have both raised their respective threat levels to the highest possible degree.

Russia's motivations for engaging in this strategic force buildup are currently unclear. Worrying for European and US policymakers is the parallel with early 2014, when Moscow conducted a major snap military exercise along Russia's western border before annexing Crimea. President Putin's decision now to move troops in the direction of the hot conflict in Eastern Ukraine, while also reinforcing Russia's presence on the Crimean peninsula, is being conducted in a similar fashion. Although most analysts do not expect a renewed invasion of the Ukrainian mainland, the possibility has not been ruled out entirely and contingencies are being prepared in European defense circles. Since the annexation of Crimea in 2014, Moscow has sought ways to integrate the peninsula with the Russian mainland, including the possibility of a "land bridge" through Eastern Ukraine, which would need to be seized by force.

A more likely scenario is one where President Putin is looking to test the new US administration and gauge the extent to which Washington reacts to perceived threats. The White House, alongside other Western leaders, have said they are "standing by Ukraine," but also intend to "keep open channels of communication with [the Kremlin], both to advance US interests and reduce the risk of miscalculation between our countries."

Despite brief glimpses of cooperation (including the clean 5-year extension of New START) relations between Moscow and Washington have bottomed out over the last several months. The Biden Administration has consistently signaled that it does not intent to "reset" relations with Russia, and that cooperation with the Kremlin will necessarily be limited to only the most urgent matters. Accordingly, President Putin's decision to apply pressure in the form of troop buildups on Europe's eastern flank will come as an unwelcome distraction to the White House. Apart from the threat of Russian military escalation, President Biden must now also deal with the high-profile human rights issue of Alexey Navalny, an anti-corruption activist whose work has posed consistent threats to the

legitimacy of the Russian regime. Since his arrest and imprisonment on politically motivated charges earlier this year, Navalny's health has rapidly deteriorated, likely at the hands of Russian security officials. If Navalny were to die in prison, the international and domestic Russian backlash would be immense and threaten virtually every area of potential cooperation with Moscow. Navalny's situation parallels that of Sergey Magnitsky, whose killing in 2009 resulted in the US Congress expanding sanctions powers against international human rights offenders. Whether the new US administration likes it or not, Moscow is inserting itself onto Washington's foreign policy agenda, with serious international security and geopolitical ramifications. With the latest threats to Ukraine's territorial integrity and slow assassination of the world's most famous anticorruption activist, Russia is signaling that it believes it can present challenges and counterbalances to US interests and European stability.




As of 2100 hours US EDT on April 5, 2021






