México Projects Part VI: Package of Laws and Regulations in Respect of the Mexican Energy Reform Secondary Laws Published

This client alert is a follow-on to our client alerts on the Mexican Energy Reform relating to the publication of the laws relating to the Mexican Energy Reform, and the rules and regulations under the secondary legislation enacted in respect of the Mexican Energy Reform.

On Friday, October 31, 2014, the regulations and rules under the secondary legislation enacted in respect of the Mexican Energy Reform were published in the *Diario Oficial de la Federación* (the Official Gazette). Stay tuned for our next client alert which will identify and analyze the substance of the new laws and regulations, and the reforms and their effects on the oil and gas and electricity sectors in Mexico.

The regulations and rules were published by the Secretaría de Hacienda y Crédito Público (Ministry of Finance and Public Credit), the Secretaría de Medio Ambiente y Recursos Naturales (Ministry of the Environment and Natural Resources), the Secretaría de Energía (Ministry of Energy), the Secretaría de Economía (Ministry of Economy), the Secretaría de Desarrollo Agrario, Territorial y Urbano (Ministry of Agricultural, Land and Urban Development), Petróleos Mexicanos (Pemex) and the Comisión Federal de Electricidad (Federal Electricity Commission), as follows:

- Decree issuing the Hydrocarbons Law, and reforming various provisions of the Foreign Investment Law, the Mining Law and the Law on Public Private Partnerships (*Decreto por el que se expide la Ley de Hidrocarburos y se reforman diversas disposiciones de la Ley de Inversión Extranjera; Ley Minera, y Ley de Asociaciones Público Privadas*)
- Decree issuing the Law of Petróleos Mexicanos and the Federal Electricity Commission, and reforming and derogating various provisions of the Law on Parastate Entities, the Law on Acquisitions, Leases and Services for the Public Sector and Related Services and the Law on Public Works and Related Services (*Decreto por el que se expiden la Ley de Petróleos Mexicanos y la Ley de la Comisión Federal de Electricidad, y se reforman y derogan diversas disposiciones de la Ley Federal de las Entidades Paraestatales; la Ley de Adquisiciones, Arrendamientos y Servicios del Sector Público y la Ley de Obras Públicas y Servicios Relacionados con las Mismas*)
