maintenance and repair of solar photovoltaic ("PV") systems at selected LAUSD sites. Proposers who are prequalified by LAUSD will be added to the list of existing pregualified providers and vendors and be eligible to submit for subsequent requests for proposals (RFPs) for solar PV installations. A typical LAUSD qualified school site will have sufficient space for approximately 200 kW. Selected providers and vendors will be provided the specific scope of work and additional information for specific project sites through subsequent RFP solicitations. Such RFPs will also define LAUSD's intent regarding financing terms and buy-out options for each specific project site, such as purchase and ownership of the solar PV systems, Power Purchase Agreements, Tax Exempt Municipal Leasing, or self-finance.
